Where as, it is found necessary that rural communities and villages by exercising their democratic rights to establish their courts, which entertains their issues and run by judges elected by them.

Where as, it is found necessary that the conflicts in the community shall be solved within it self in order to obtain the appropriate vedict, and to come up with the huge costs and suffering.

Now there fore, in coordance with Article 49(3) (A) of the revised continent of the Somali regional state and proclamation No. 76/2002, the Somali regional state council proclamation as follows:

- 1. ማሕበራዊ ፍ/ቤት ማናቸውንም ጉዳይ የሚያየዉ በገደብ ትራት ይሆናል፣ ሆኖም ስለሕብ ሙዕካም ፀባይ ጩዳም ዳኝነት አስረገገ ሆኖ ሲያገኝ ነገር በዝግ ትራት ያስቸገላል።
- 2. ማሕበራዊ ፍ/ቤት በተበሉ ሙደቦች ትራት ሥርራ ያስቸገላል፣ ሆኖም ለተወጣሩ ፍትሕ አሰጣጥ አስረገገ ሆኖ ሲያገኝ በተበሉ ጩዳ ስለሆነ በማናቸውም ሥርራ ያስቸገላል።
- 3. አያንዳንዱ ማሕበራዊ ፍ/ቤት የሕዝቡን የሥራ፣ የኑሮና የእምነት ሁኔታ ገንዛቤ ጩዳ በማስገባት የማስቻል ቀንና ሰዓቱን ይጠሰናል።

PART TWO

ORGANIZATION AND ADJUDICATION PROCEDURE OF THE SOCIAL COURT

Article 5 **Indipendence**
The social court shall exercise judicial function independently and within the limits prescribed by law.

Article 6 **organization and the number of judes in the social court**

- The social courts shall have:
- 1. Chairperson and two regular judges, and two alternate judges, who come on duty on the vacancy of seat,
 - 2. One registerar,
 - 3. The social court is a ccountable to the council of the kebele it locates.

Article 7 **open sitting date and place of hearing**

- 1. The social court shall hear a case in an open session, however the court may hear a case in closed session by protecting the privacy of the parties concerned and the judiciary.
- 2. The social courts shall hear a case by sitting in the kebele it resides, or any where else in the kebele when it encompasses fairness and speed of the trial.
- 3. The social court taking into consideration burden, life and the religion of the society shall determine the hearing date and hours

Article 8 **Disqualification of the judges for hearing a case**

1. A judge is disqualified to hear a case if he is spouse, assendant, descendent or other relation-ship or there is hatred between him and one of the parties of the case; or he rasided his opnion on the matter prior to the hearing, or mediated the parties .

 - ለ. ከፍተኛ የመምራት ብቃት ሞራል ያለውና በሀብረተሰቡ ዘንድ ከፍተኛ ተሰማራኝነት ያለው ፤

- 2. ማንኛውም የተባሉ ነዋሪ ሆኖ የተባሉ ም/ቤት ወይም የአስተዳደር ም/ቤት አባል የሆነ ሁሉ ይህ መመዘኛ አይመለከተውም ።

- 2. A judge who realizes the existence of the matters provided under Sub-Article 1 of this article shall immediately disqualify himself the hearing.
- 3. However if the judge isn't disqualified by himself. The concerned party may submit disqualification claim to the sitting, the other judges will investigate the matter.
- 4. The decision rendered on judge not disqualified him-self from the hearing.
- 5. Where a judge has been disqualified from the hearing an alternate judge shall replace him and hear the matter.

PART THREE

Election, Nomination and Term of Office of Social Court judges

Article 9 Eligibility for Social court Judges:-

- 1. Anyone resident in the kebele, and fulfils the following qualifications shall be elected as social court judge:-
 - a) Above 25 years of age
 - b) Well vested on leadership trust-ful, high moral character and well respected by the society
 - c) committed to become a judge
 - d) Has knowledge on customary law and relied by the society.
- 2. Any one, resident in the kebele who's member of the kebele council or the executive council isn't lligible.

PART FOUR

The Registrar of the Social Court
Article 15 selection and employment of the social court registrar

1. Any one, resident is the kebele who fulfils the following requirement is illegible to be nominated as registrar.
 - a) High moral character (competency and honesty gained respect).
 - b) At least 18 years of age.
 - c) Attained or graduated from grade 8.
 - d) Not employed in another office.
2. The kebeles and city administrations shall appoint as registrar on any one resident at the kebele and fulfils the requirements provided by sub-Article 1 of this Article.
3. The registrar of the social courts near the cities shall be on duty on week days starting from Monday to Thursday.

Article 16 the selection, appointment and term of office of the social court Registrar in rural kebeles

1. Any one who fulfill the following requirements may be selected to become social court registrar:
 - a) He must be transparent, honest high moral character and well respected by the community .
 - b) Not less than 18 years of age
 - c) Can read and write
 - d) Reesident in the kebele and committed to serve the society as registrar.
2. The rural kebeles may nominate as registrar on any who is resident at the kebele and fulfill the requirements provided by Sub-Article 1 of this Article.

Article 17 power and duties of the registrar of the social court

The registrar of the social court, who is accountable to the chairman of the court, shall have the following powers and duties.

- 1. Shall receive claims inspect and ensure the contents here in, at the same time ensure whether the court has jurisdiction to hear such case, there fore submit to sitting of the court.
- 2. Shall prepare and issue to appellants a copy of the court judgment .
- 3. Shall issue and announce the orders of the court during session.
- 4. Shall administer the daily and administrative activity of the court.

PART FIVE

JURISDICTION OF THE SOCIAL COURT

Article 18 territorial jurisdiction of the court

- 1. A social court established under this proclamation shall have territorial jurisdiction on the following matters.
 - a) Where the accused resides in the kebele which the court is established,
 - b) Where the cause of Action of matter started in the kebele in which the court is established,
 - c) Where the offence was committed in the territorial jurisdiction of the kebele, in which the court was established.

3. Cases relating to buildings without permission, walls and fences.
4. Cases relating to payment of rent and other services not exceeding 500 birr (five hundred birr) of dwelleries and plots situated in urban or rural lands,
5. Cases relating to fences. Walls rehabilitation, maintenance of lost property, servitudes and other common property, trees and the responsibilities that arise on rain water on the surface and under the ground.
6. the social court may issue certificates of evidence for an exeption of charges of government services, by insuring the living stander of the person.

Article 20 criminal jurisdiction of the social court

The social court shall issue a verdict on the following cases:-

Article 21 Sentences Penalty

Where a social court:-

1. Finds the defendant guilty, may impose according the gravity of offence any one of the following penalties:-

A) Warn the offender;

B) Order the offender to make an apology to the injured person.

C) By taking into account on the financial position of the accuse, shall sentence a fine not exceeding 800 birr.

D) Over time working hours of not exceeders to 10 days.

E) Imprisonment not exceeding one month.

F) Where the crime has caused damage on property or injury to a person, the court may order the defendant to pay damages not more than 800 birr.

2. Where the accused is found to have been committed in a number of offences, or committed one offence in several time the court may impose more than one sentence as provided by Sub-Article 1 on this Article3.

3. Where its found necessary, the court may order the confiscation of any property or arms, used for the commission of a crime without prejudice the sentences provided by Sub-Article 2 of this Article.

4. Where the accused committed the crime at the refreshment centers or similar places, the court, if sees fit may pass an additional sentence of prohibiting the accused to from such places for a period not exceeding on month.

2. Whoever in Court sitting or any where else obstructs or attempts to obstruct the proceeding of the court shall be imposed on sentence not exceeding 12 days.

PROCEEDINGS OF THE SOCIAL COURT

Article 23 Establishment

1. the social court shall follow the procedures laid down by this proclamation.

2. any one attending the proceedings may after the permission of the presiding judges raise opinion on deficiency by highlighting the custom.

3. The presiding judge of the court by referring to the customary laws of the area, may negotiate the parties together the separately.

4. Whenever found necessary the court may hear witnesses, the witness shall be heard in a manner consistent with the custom of the area.

Article 26 procedure of serving summons

1. Any one who is party to a suit in the social court in order to follow and prepare himself for the proceedings, shall be informed by indicating the name of the plaintiff type of the suit data and the place of the suit.
2. The method of informing the parties to a suit may be oral or written.

Article 27 presenting evidences

1. the social court, in order to decide a case, may summon witnesses, or order that evidences shall be brought before it,
2. Any person, bureau or authority has an obligation to appear before the court where he is summoned, or present evidences in the appropriate time.

Article 28 re-opening a closed case

Whenever the social court presumed the closure of the case is inconsistent to the procedure of the case, it may re-open the case.

Article 29 The reasonable circumstance

Whenever the kebele social court presumed the security and well being of the community at risk it may suspended the case for time.

Article 30 the procedure of hearing a case

1. The hearing of a case shall held on the date and time specified by the court,
2. Before hearing, the court shall ensure the presence of the parties.
3. In criminal proceedings, in order to enable the accused to hear his case and defend, himself, he shall be present all the proceedings.

Article 31 suspension of the case

The plaintiff may withdraw his claim any time before the social court issues a verdict.

1. ውሳኔ የሚያስተላልፈው በሙሉ ድምጽ ነው ሆኖም ግን በሙሉ ድምጽ በማይኖርበት ጊዜ በአብዛኛው ድምፅ እንዲወሰን በማድረግ የተለዩ ሀሳብ ያለው ጻፍ ደግሞ በውሳኔ ላይ ይጠቀሳል።
2. የክርክሩ ፍሬ ነገሩ የግራ ቀኙ ክርክሮች የምስክርነት ቃል ለክርክሩ የቀረበው ማስረጃ ዓይነት በሁሉ በውሳኔው ላይ መጠስ አለበት።

34. የውሳኔ ስፈጸም ሥርዓት

1. የማህበራዊ ፍ/ቤት ውሳኔው የይግባኝ ፍ/ቤት ካላቋረጠ በስተቀር ከተወሰነበት ቀን ጀምሮ በአምስት ቀናት ውስጥ መፈጸም አለበት።

Article 32 closing the case

Whenever a social court finds that a civil brought before it, is outside its jurisdiction the court shall close such case.

Article 33 judgement issuing procedure

A social court

1. Shall decide a case by absolute majority, however where absolute majority vote can't be obtained, the court may deride by a simple majority vote, where as special opinion shall be highlighted.
2. In judgement , the statement of the parties, evidences presented and the reason the judgement is based shall be stated it summary.

Article 34 Execution of judgement

1. A social court judgement, unless stayed by the appellate court shall be executed within five days starting from the announcement.
2. Without prejudice the provision of the preceding sub-Article 1, if appeal was taken from matters such as terms of imprisonment, or review of fine sentence more than 400 birr, or property valued more than 500 birr if the worda court hasn't stayed such judgement shall be executed within 25 days starting from the announcement of the judgement.

- 3. - 3. Where as, the fine ore state revenue, therefore the kebele administration for the proper accomplishment of the mission, may use 50% of the collected fines for execution activities and deposit the remaining 50% to the state revenue.
- 4. Where the defendant is able to pay such fine, but is not willing, the court shall order that the judgement shall be executed on his property.
- 5. Where the court finds that defendant, the court may change the sentence to compulsory labor.
- 6. A cording to this proclamation sentences or imprisonments passed by the social court shall be executed on the place decided by the kebele administration .

Article 35 Appeals

- 1. Where a party to suit isn't satisfied to a social court judgement such party may submit an appeal to the appellate judges within 5 days.
- However an appeal may be taken only on the following matters.
 - a))Where the court refused to hear evidence or material witness
 - b) Where the judgment is impartial
 - c) Where the court heard one of the parties and not the other.
 - d) Where the judge is unduly influenced by one party whether by bribes or other things that may obstruct the proceedings.

- 2. An interested party may file an appeal within 30 days from the announcement of the judgement.
- 3. Where a memorandum of appeal is submitted to the appellate court, the court shall first examine whether the grounds of appeal are corresponding to provisions of the preceding Article, then may summarize the appellate and try to negotiate the matter, however if negotiation fails, the court shall render the verdict if sees fit such verdict is final.
- 4. Without prejudice the provisions of the preceding sub-Article, where the parties submit to court they prefer arbitration, the court may hear such case in the manner prescribed by the customary law.

PART SEVEN

Miscellaneous Provisions

Article 36 Court fee

where as, the parties shall cover themselves for costs during the proceedings, however, where the court ascertains that plaintiff instituted the suit with intent to cause undue inconvenience to the defendant, it may order the plaintiff to pay 250 birr to the defendant.

Article 37 Judicial Revenue

1. The cases submitted to the social courts at the kebeles shall be charged on reasonable and appropriate fee.

Article 38 Procedure of collecting the fines

1. The social court of the kebele shall collect fines by a legal receipts .

2. The details will be defined by the directives of the finance and economic development bureau.

Article 39 Court report

The kebele social court may consecutively submitted to kebele administrative council, urban court or worda court , their performance report and the challenges they come across.

Article 40 Duty to co-operate

All public organs and state bureaus shall have a duty to co-operate to the social court for the proper accomplishment of its mission

Article 41 Inapplicable laws

Any law, regulation or practice inconsistent with proclamation shall not be applied with respect to matters provided for in this proclamation.
