Where as, the Context and volume of the constitutional Requires a an amendment and enactment of additional provisions. <i>NOW, THEREFORE,</i> The council of the Somali Region in accordance with Article 49(3.A) of the revised Constitution of the Somali Regional State, it is hereby proclaimed as follows: <i>1. Short Title</i> This Proclamation may be cited as the “ <i>Proclamation to pronounce the</i> <i>Amendments of the constitution of</i> <i>Somali Regional State, Proclamation</i> <i>No. 107/2003.</i> ” <i>2. Amendment</i> The revised constitution of Somali regional state is made the following amendments:- 1. The following new alphabet (M) is added under Article 49 sub- article (3) of the Revised Constitution of the regional state: “(M)” In conformity with the power of the region given under Article 47 (2, M) of the Constitution it shall declare a state of emergency;

1. Qodobka 49^{aad} farqada 3^{aad} ee
 dastuurka dib loo habeeyay ee
 dawlada deegaanka waxaa lagu soo
 daray xarafka cusub ee hoos ku
 cad:

“(M)” wuxuu hab wafaaqsan
 awooda deegaanka lagu siiyay 47^{aad}
 farqada 2^{aad} xarafka ‘M’ ayaa wuxuu
 ku dhawaaqi karaa bayaanka

2. Qodobka 59^{aad} ee dastuurka dib loo habeeyay ee dawlada deegaanka soomaalida waxaa lagu soo daray labbadan farqo ee 9^{aad} iyo 10^{aad} ee hoos ku cad iyadoo farqadii 9^{aad} iyo 10^{aad} ee qodobkan ay u guurayan farqada 11^{aad} iyo 12^{aad} ee qodobka:-

“(9)” wuxuu diyaariyaa islam-rkaana u gudbiyaa golaha xildhibaanada deegaanka bayaanka qabyada ah ee xaalada deg-dega ah.

10” Iyadoo ay sidooda yihiin adwooda golaha xildhibaanada lagu siiyay hab waafaqsan qodobka 49 farqada 3^{aad} xarafka M ee dastuurka ayaa wuxuu Golaha Hawlfulinta deegaanku soo saari karaa islamarkaana dhaqangalini bayaanka xaalada deg-dega ah marka aanu Goluhu shirsanayn ee ay deegaanka ka dhacaan dhiibaatooyin dabici ah ama uu ka dilaaco cudur khatar galinaya caafimaadka bulshada.

3. Qodobka 61^{aad} farqada 3^{aad} ee dastuurka dib loo habeeyay ee dawlada deegaanka waxaa lagu soo daray xarafka cusub ee hoos ku cad:-

“(G)” wuxuu shan iyo toban maa-lmood gudahood ku saxeexa bayaanada iyo xeerarka ay ansixiyaan hay’ada sharci dejinta iyo fulinta si loogu soo saaro Dhool Gazeeta.

4. Qodobka 84^{aad} farqada 3^{aad} ee dastuurka dib loo habeeyay ee dawlada deegaanka waxaa lagu soo daray farqadan 2^{aad} ee cusub iyadoo farqadii hore ee 2^{aad} ay u guuraysa farqada 3^{aad}:-

“(2)” iyadoo sideeda loo tixgal-inayo farqada 1^{aad} ee qodobkan, madaxwaynaha dawlada deegaanku wuxuu marka loo arko in ay ku jirto danta guud ee bulshada deegaanka magaacabi karaa islamarkaana isku badal ku samayn karaa Gudoomiyaayasha deegmooyinka. Faah-faahintana waxaa xeerin doona sharciga.

2. የተሻሻለው የሱማሌ ክልል ሀገ-መንግስት አንቀጽ 59 የሚከተለው አዲስ ንዑስ አንቀጽ 9 እና 10 ተጨምረው የአንቀጹ የቀድሞ ንዑስ አንቀጽ 9 እና 10 ንዑስ አንቀጽ 11 እና 12 ይሆናሉ።

9” የአስቸኳይ ጊዜ አዋጅ ረቂቅ በማዘጋጀት ለክልሉ ምክርቤት ያቀርባል

10” በሀገ-መንግስቱ አንቀጽ 49(3 ቸ) መሠረት ለምክርቤት የተሰጠው ሥልጣን እንደተጠበቀ ሆኖ የምክርቤት ስብሰባ በማይካሄድበት ጊዜና የተፈጥሮ አደጋ ለሀዘብ ጤና አደጋ የሆነ ወረርሽኝ በክልሉ ውስጥ በሚከሰትበት ጊዜ የክልሉ መስተ ዳደር ምክርቤት የአስቸኳይ ጊዜ አዋጅ በማወጣት ተግባራዊ ያደርጋል

3. በተሻሻለው የክልሉ መንግስት ሀገ-መንግስት አንቀጽ 61 ንዑስ አንቀጽ 3 የሚከተለውን አዲስ ተራ ቁጥር ተጨምሯል።

‘G’ በክልሉ ምክርቤትና በመስተዳደር ምክርቤት ያፀድቁትን አዋጆችና ደንቦች በደል ጋዜጣ አንዲታወጅ በአ ሥራ አምስት ቀናት ውስጥ ይፈረ ማል።

4. በተሻሻለው የክልሉ መንግስት ሀገ-መንግስት አንቀጽ 84 ንዑስ አንቀጽ 3 ሥር የሚከተለው አዲስ ንዑስ አንቀጽ 2 ተጨምሮ የቀደሞው ንዑስ አንቀጽ 2 ወደ ንዑስ አንቀጽ 3 ተሻግረዋል።

(2) የንዑስ አንቀጽ 1 ድንጋጌ እንደተጠበቀ ሆኖ ለክልሉ ሀዘብ ሁለንተናዊነት አስፈላጊ ሆኖ ሲገኝ የክልሉ መንግስት ፕሬዝዳንት የወረዳ ሊቀመናበራት (አስተዳዳሪ ሪዎች) በመሾምና በማሸግ ሊመድብ ይችላል። ዝርዝሩ በህግ ይወሰናል።

3 አዋጅ የሚጻፍበት ጊዜ ይህ አዋጅ በክልሉ ምክርቤት ከተፀደቀበት ቀን ጀምሮ የፀና ይሆናል።

2. The following two new sub-article (9 and 10) are added under Article 59 of the Revised Constitution of the regional state and sub Article (9 and 10) of the Article are re-numbered as 11 and 12 respectively:

“(9)” shall prepare and submit to the council, the proclamation declaring a state of emergency.

“(10)” Notwithstanding to the power vested to the council under sub-Article (3, M) of Article 49 of the constitution , The State Cabinet Council shall have the power to issue the declaration of State of Emergency should any natural disaster or epidemic that threatens the health of the people occur and when the State Council is not in session.

3. The following new alphabet is added under sub-Article (3) of Article 61 of the Revised Constitution of the regional state;

“(G)” Shall sign within fifteen days Proclamations and regulations passed by the council and the executive organ in order to publish in dhool Gazeta.

2. The following new sub-article (2) is added under Article 84 of the Revised Constitution of the regional state and sub Article (2) of the Article is re-numbered as sub-Article 3 of it:

“(2)” .Notwithstanding to the sub-Article 1 of this Article , the president of the regional state may assign and transfer the Woredas Chairmans where found necessary for the well being of public of the region. Details shall be determined by law.

3 *Effective Date*
This proclamation shall come into force on the date approved by the regional council.
