PROCLAMATION NO- 108/2003
THE AMENDED CHAT TAX
PROCLAMATION OF SOMALI
REGIONAL STATE

WHEREAS, it is found necessary, to proclaim a tax levied on the sales of chat to be consumed within the region by taking into consideration the special nature of the chat and the appropriate type of tax.

WHEREAS, it is found necessary to strengthen and increase the revenue collected from chat tax.

WHEREAS, it is found necessary to amend the chat tax proclamation no 65/2000.

NOW, THEREFORE, in accordance with Sub-.Article (3) (A) of Article 49 of the revised Constitution of the Somali regional state, it is hereby proclaimed as follow:-

1. Short Title

This Proclamation may be cited as the “Chat Tax Amendment Proclamation of Somali Regional State. Proclamation No. 108/2003”.

2. Amendment

Sub-Article (2, A) of Article 3 of the chat tax Proclamation No. 65/2000 is deleted and replaced by the following new alphabet (A):

(A)” Any chat product transported into and to be consumed within the region shall be paid 6 (six) birr of tax per kilo.

3. Effective Date

The Proclamation shall enter into force upon it’s publication in the Dhol Gazeta.
