Article 1 short title

This proclamation may be cited as “Supplementary budget proclamation of 2004 annual budget” proclamation no – 109/2004.

Article 2 Implementation of the Supplementary budget.

The regional parliament approved that the following Supplementary budget to be used as salary and Capital:

1. Surplus of the Central Treasury	23,000,000.00
2. Debt for Procurement of vehicles for the three City Administrations	4,545,000.00
3. Surplus revenue of the region	9,291,134.40
4. Money donated to harsh in (LIG) project.....	5,589,693.00
Grand total:	42,425,827.40

Article 3 the Supplementary budget shall be used on the following purposes

a) The surplus of the Central Treasury and the Surplus Revenue collected by the Revenue bureau which is 32,291,134.40 shall be used on:

Salary Contingent	11,291,134.40
Other Contingent	<u>21,000,000.00</u>
Total Contingent	32,291,134.40

አንቀጽ 5. የሌሎች መጠባበቂያ በጀቶች አስተዳደር

በክልሉ ፕራዥድንት ፍቃድ ሳይሰጥ እና ደህንንም ፍቃድ የካቢኔት ም/ቤት ሳይፀድቀው የሌሎች መጠባበቂያ በጀቶችን መጠቀም አይቻልም።

አንቀጽ 6. የተቀማጭ በጀት ምደባ

በክልሉ ዞንና ወረዳ ቢሮዎች ላይ የደምዘን እጥረት ሲያጋጥም እና በዚህ አዋጅ በአንቀጽ 4 ላይ የተገለጸው የመጠባበቂያ ደምዘን በጀት ለደምዘን በቂ ሳይሆን ሲቀር የካቢኔት ም/ቤት በአንቀጽ 5 ላይ የተገለጸውን የሌሎች መጠባበቂያ በጀቶችን ለደምዘን እጥረት ሲያዘዋውር ይችላል።

b) The money borrowed from the Central Treasury used to Procure cars for Godey, Kebri-dahar and Dagahbur which is 4,545,000 shall be included as Supplementary budget for the above mentioned City administrations.

c) Money donated to Harshin (LIG) project which is 5,589,693 birr shall be used as Capital budget by the woreda on development projects drafted at the beginning of 2004 Fiscal year.

Article 4 administration of Contingent Salary budget

The Somali regional state finance and economic development bureau shall administer the Salary Contingent Budget to solve any imbalance on regional bureaus zonal and woreda offices.

Article 5 the administration of the other Contingent budget.

The other Contingent budget shall not be used unless permitted by the president of the Somali regional state and approved by the Cabinet Council.

Article 6 allocation of the Contingent budget

If the Contingent Salary mentioned in article 4 is not sufficient to cover the required sum the Cabinet council may Transfer the other Contingent budget mentioned in article 5 as salary which will be covered on salary which will be covered on salary imbalances in regional bureaus, zonal and woreda offices.

Article 7 the Somali regional state finance and economic development bureau shall have the power to Transfer budget on salary and allowances which is not used by the regional bureaus and Zonal offices to the negative imbalance of the salary and allowances of the other regional bureaus and Zonal offices.

Article 8 the Somali regional state finance and economic development bureau shall have the power to Transfer budget on Salary and Allowances to Pity cash.

Article 9 Effective date
This proclamation shall come it to force on the day the regional council approves.
