Whereas, It Is Deemed Necessary to encompass a deputy Manager to the organizational setup of Revenue Authority of Somali Regional Authority so as to achieve an efficient performance in the implementation of Authority's objectives and policies.

Whereas, proclamation 114/2004 which provides for the reestablishment of Revenue Authority of Somali Regional Authority do not establish the powers and duties of a deputy Manager of Revenue Authority and deem necessary to complement the supplementary provisions to existing Proclamation.

NOW, THEREFORE, In accordance with Article 49(3, A) of the Revised Constitution of the Somali Regional State, it is hereby proclaimed as follows:
