**PROCLAMATION NO 148/2006**

**PROCLAMATION TO PROCLAIM THE ESTABLISHMENT OF ETHIOPIAN SOMALI DESIGN SUPERVISION WORKS ENTERPRISE**

Whereas, it is found necessary to establish in the Region an autonomous Enterprise responsible for study, design and supervision works.

NOW, THEREFORE, the Council in accordance with Article 49(3, A) of the revised Constitution of the Somali Regional State of Ethiopia Council of Region, has proclaimed as follows:

**PART ONE  
GENERAL PROVISIONS**

**1- Short Title**

This Proclamation may be referred to as the "Establishment Proclamation of Ethiopian Somali Design Supervision Works Enterprise Proclamation No 148/2006"

**2- Definition**

Unless the context requires otherwise, in this proclamation:-

1. "Wakaalad" waxaa loola jeedaa wakaalada hawlaha daraasaadka, naqshadaynta iyo Dabagalka ee Soomaalida Itoobiya oo lagu asaasay qodobka 3<sup>aad</sup> ee bayaankan.
2. "Boordhi" Waxaa loola jeedaa gudiga hogaaminta wakaalada sida ku cad Qodobka 7<sup>aad</sup> ee bayaankan.

**Qaybta Labad**

**Aasaaska, U Tirsanaanta Iyo Qaab-dhismeedka wakaalada**

**Qodobka 3<sup>aad</sup>: Aasaasida Iyo U Tirsanaanta wakaalada**

1. Bayaankan waxaa lagu aasaasay Wakaalada Hawlaha daraasaadka, Naqshadaynta iyo Dabagalka ee Soomaalida Itoobiya oo wixii hada ka dambeeya loogu yeedhi doono "Wakaalada" oo ah Wakaalad dawli ah oo madax banaan lehna jiritaan sharci.
2. Wakaaladu iyadoo leh madax-banaani maamul iyo xirfadeed hadana, waxay hoos tagta xafiiska Maamulka Dawladda Deegaanka.

**Qodobka 4<sup>aad</sup>: Xarunta Wakaalada**

Xarunta wakaaladu iyadoo ay tahay magaalada jigjiga, hadana hadba sida ay lagama maarmaan ugu tahay shaqada waxay laamo ku yeelan kartaa Xarumaha iyo meelaha laga fulinayo mashaaricaha.

**አንቀጽ 3. ስለድርጅቱ መቋቋምና ተጠሪነት**

1. የኢትዮጵያ ሰማሌ ክልላዊ መንግሥት የጥናት፣ ዲዛይንና ቁጥጥር ድርጅት (በዚህ በኋላ «ድርጅት» የተባለ የሚጠራ) ራሱን የቻለ ህጋዊ ሰውነት ያለው የመንግሥት የልማት ድርጅት ሆኖ በዚህ አዋጅ ተቋቋሟል።
2. ድርጅቱ በሕግና በሙያ የሚኖረው ነፃነት እንደተጠበቀ ሆኖ ተጠሪነቱ ለክልሉ መስተዳደር ምክር ቤት ጸ/ቤት ይሆናል።

**አንቀጽ 4. የድርጅቱ ዋና መሥሪያ ቤት**

የድርጅቱ ዋና መሥሪያ ቤት በጅጅጋ ከተማ ሆኖ እንደአስፈላጊነቱ ፕሮጀክቶች በሚከሄዱበት ሌሎች አካባቢ ጣቢያና ማዕከላት ይኖረዋል።

**አንቀጽ 5. ስለድርጅቱ አቋም**

ድርጅቱ የሚከተለው አቋም ይኖረዋል፡

1. የሥራ አመራር ቦርድ
2. በክልሉ ፕሬዝዳንት የሚሾም አንድ ዋና ሥራ አስኪያጅና ምክትል ሥራ አስኪያጅ።
3. ሌሎች ለሥራው አስፈላጊ የሆኑት ሠራተኞችና የሥራ ሂደቶች ይኖሩታል።

1. "Enterprise" means the Ethiopian Somali Design & Supervision Works Enterprise established under Article 3 of this proclamation.
2. "Board" means the Management Board of the Enterprise established under Article 7 of this proclamation.

**PART TWO**

**ESTABLISHMENT, ACCOUNTABILITY AND ORGANIZATIONAL SETUP OF THE ENTERPRISE**

**3. Establishment and Accountability of the Enterprise**

1. The Ethiopian Somali Design & Supervision Works Enterprise (hereinafter referred to as "Enterprise") is established by this Proclamation as an Autonomous Public Enterprise Having Legal Personality.
2. Without prejudice to its professional independence, the Enterprise shall be accountable to the office of the Administration.

**4. Head Office**

The Enterprise shall have its head office in Jijiga. However, it may have branches in centers and sites as may be necessary.

**5. Organizational Setup of the Enterprise**

The Enterprise shall have the following organizational setup:

1. Management Board,
2. A General Manager appointed by the President of the Region.
3. The necessary core professional staffs.

3. To carry out survey an and specifications hydraulics, small hyd geotechnical, dam and structure, medium flooc water supply, sewerage road, building, bridges a related works.
4. To render consultant regarding studies an evaluation of concerning water wor bridges and constriction
5. renders services regardl and design evaluation c water works, roads, br constriction works as laboratory services of v and buildings.



**Qodobka 8<sup>aad</sup> Awoodaha iyo waajibaadka Boordhiga**

Boordhigu wuxuu yeelan Awoodaha iyo Waajibaadyadan hoos ku cad:-

1. Wuxuu soo saaraa awaamiirta iyo hab-raacyada lagu hogaamiyo maamulka shaqaale iyo maaliyadeed wakaaladu kuhawlgasho.
2. Wuxuu marka uu qiimeeyo ansixiya qorshaha shaqo ee wakaalada iyo warbixinta isticmaalka maaliyadeed ee u hanti-dhawrka dibadeed ee u'idman soo bandhigo.
3. Wuxuu xaqiijiyaa habsami u daryeelka hantida wakaalada iyo sida hantida iyo cuduuda shaqaale loogu hirgallinayo yoolka horumarka bulsho dhaqaale ee deegaanka iyo himilada wakaalada.
4. Wuxuu jeexaa nidaamka iyo tabaha ay wakaaladu ku gaadhayso inay yeelato awood fulineed oo u sahlaya ka qaybgalka tartanada heer deegaan, qaran iyo kuwa caalamiga ahba.
5. Wuxuu magacaaba hantidhawr dibadeed oo idman oo Sanadkiiba hal mar ama hadba sida loogu baahdo baadhis ama hanti-dhawrka xisaabeed ku sameeyaa dhokumeentiyada maaliyadeed iyo hantida wakaaladaba.
6. Wuxuu soo jeediyaa talooyin la xidhiidha kordhinta ama dhimista raasamaalka wakaalada.
7. Wuxuu si go'aan looga gaadho Golaha Hawl Fulinta Deegaanka u dhaweeyaa hanaanka qaybsiga macaashka ee ay shirkadu soo xeerayso.
8. Wuxuu talo ka bixiyaa xulaashada Maareeyaha Guud iyo maareeye ku xigeenka Wakaalada.

**አንቀጽ 8. የቦርድ ሥልጣንና ተግባራት**

የድርጅቱ ቦርድ የሚከተሉትን ሥልጣንና ተግባር ይኖረዋል:-

1. የድርጅቱን ሠራተኞች እና የፋይናንስ እንቅስቃሴ የሚመራበት መመሪያዎችና ማንግሎትን ያፀድቃል።
2. የድርጅቱን የሥራ ዕቅድና በውጭ አዲተሮች አማካይነት የቀረበው የፋይናንስ አጠቃቀም ሪፖርት መርምሮ ያፀድቃል።
3. የድርጅቱ ሀብት በአግባቡ መጠበቁንና እንዲሁም ሀብትና የሰው ኅይወት በአግባቡ የድርጅቱን ሥራዎችና ዓላማዎች ለማሳካት ብቻ መዋላቸውን ያረጋግጣል።
4. ድርጅቱ ክልላዊ፣ ሀገር አቀፍ እና አለም አቀፋዊ ጨረታዎች ሊያሳትፍ የሚያስችል የማስፈጸም አቅም እንዲኖረው የሚያስችል ሁኔታና ሥርዓት ይቀይላል።
5. በየዓመቱ አንድ ጊዜ ወይም እንደአስፈላጊነቱ የድርጅቱን የፋይናንስ ሠነዶች እና ንብረት የሚመረምር የውጭ አዲተሮች ይሰይማል።
6. የድርጅቱ የካፒታል መጠን እንዲያደግ ወይም እንዲቀንስ በተመለከተ አስተያየት ያቀርባል።
7. የድርጅቱ ትርፍ አከፋፈል ሁኔታ በክልሉ አስፈጻሚ ምክር ቤት ውሳኔ እንዲያሳልፍ የራሱን ሀሳብ ያቀርባል።
8. የድርጅቱን ዋና ሥራ አስኪያጅና ምክትል ሥራ አስኪያጅ አመራረጥ አስተያየት ይሰጣል።

**8: Duties and Responsibilities of Board**

The Board shall have the following Duties and Responsibilities;

1. Approves the directives manuals governing administration of employees financial systems of Enterprise.
2. Discuss and approve the and budget of the Enterprise reports on utilization of funds presented to it by external Auditors,
3. oversee the administration human, material, and Financial resources of the Enterprise such a manner and for purposes consistent government policies;
4. Design ways and means promoting the enabling capacity of the Enterprise to bid for regional, national international tenders.
5. Designate an external auditor the Enterprise who shall announce or as deemed necessary a The books of accounts financial documents of Enterprise;
6. Forwards proposals regarding the increment or decline of authorized capital of Enterprise.
7. Forwards proposals regarding distribution of profits generated by the enterprise and submit the executive organ of the state
8. recommends the appointment of the General Manager deputy Manager of Enterprise;

9. Wuxuu ansixiyaa shaqaalaynta iyo eriga saraakiisha sare ee wakaalada ee toos u hoos taga maareeyaha Guud ama kuxigeenka maareeyaha,

10. wuxuu ansixiyaa mushaaharka iyo gunooyinka maareeyaha, maareeye ku-xigeenka iyo saraakiisha sare ee wakaalada,

11. wuxuu qaybaha ay khuseeyso u gudbiyaa warbixin xiliyeedka Wakaalada.

12. Wuxuu go'aan ka gaadhaa hawlaha kale ee uu maareeyaha Guud soo hordhigo.

Qodobka 9<sup>aad</sup> Hanaanka Shirar ee Boordhiga

1. Shirarka caadiga ah ee boordhigu wuxuu qabsooma sadeexdii biloodba hal mar, hase yeeshee, markasta oo ay lagama maarmaan noqoto wuxuu yeelan karaa shir deg deg ah oo aan caadi ahayn.

2. Shirarka boordhigu wuxuu ku qabsoomaya marka ay shirka joogan xubnaha boordhiga intooda badan( 50+1).

3. Go'aanada boordhigu waxay ku meel maran cod hal dheeri ah ee xubnaha ka soo qayb galay shirka. Hase yeeshee, hadii codka xubnuhu uu is le'eg noqdo waxaa lagu go'aan qaadan dhanka uu shir gudoonku u codeeyo.

4. Iyadoo arrimaha lagu xusay qodobkan sidooda ahaanayaan, Boordhigu wuxuu dajisan karaa nidaam u gaara hanaankiisa shirar.

1. የቦርዱ መደበኛ ስብሰባዎች በየሦስት ወሩ አንድ ጊዜ ይካሄዳል። ሆኖም አስፈላጊ ሆኖ ሊገኝ በማንኛውም ጊዜ አስቸኳይ ስብሰባ ሊያካሄድ ይችላል።

2. ከቦርዱ አባላት ከግማሽ በላይ በስብሰባው ከተገኙ ምልዕተ ጉባኤ ይሆናል።

3. የቦርዱ ውሳኔ በአብላጫ ድምፅ ሆኖም ድምፅ እኩል በእኩል የተከፈለ እንዳሆነ ሰብሳቢው የሚደግፈው ሀሳብ የቦርዱ ውሳኔ ይሆናል።

4. የዚህ አንቀጽ ድንጋጌዎች እንደተጠበቀ ሆኖ ቦርዱ የራሱን የስብሰባ ሥነ-ሥርዓት ሊያወጣ ይችላል።

አንቀጽ 10. ስለዋና ሥራ አስኪያጁ ሥልጣንና ተግባራት

የድርጅቱ ዋና ሥራ አስኪያጅ

9. Approves the employment and termination of senior employees of the Enterprise directly accountable to the General Manager,

10. Shall approve the salary scale and allowances of the General Manager, deputy Manager and other senior officers of the Enterprise.

11. Shall submit a quarterly report on the activities of the Enterprise to the concerned organs.

12. Shall pass decisions on matters presented to it by the General Manager.

9. Meetings of the Board

1. The Board shall hold regular meetings once every three months; however, The Board may call extraordinary meetings at any time, as may be necessary.

2. The meeting shall constitute a quorum in the presence of more than half of the members.

3. The decision of the Board shall be passed by the majority vote. In the case of tie, the idea supported by the chair person shall be the decision of the Board.

4. Without prejudice to the provisions of this Article, the Board may adopt its own rules of procedures and manual.

PART FIVE

POWERS AND DUTIES OF THE GENERAL MANAGER

10. powers and duties of the General Manager

The General Manager of the Enterprise shall have the following

1. Wuxuu Haggaa, maamulaa islamarkaana kormeeraa shaqooyinka wakaalada.
2. Wuxuu isku dubaridaa xafiiska wakaalada, diyaariyaa qaab-dhismeedka wakaalada, mushaaharka iyo gunooyinka shaqaalaha iyo masuuliyiinta shirakada la siinayo una gudbiyaa boordhiga marka la ansixiyana wuu dhaqangaliya.
3. Wuxuu magaca wakaalada ku furaa kuna dhaq dhaqaajiyaa akawanka xisaabta bangiga ee wakaalada.
4. Wuxuu diyaariyaa islamarkaana boordhiga hordhigaa qorshaha wakhtiga gaaban, dhexe iyo midka fog kuna dhaqmaa marka loo ansixiyo.
5. Wuxuu boordhiga u gudbiyaa kana ansixiyaa shaqaalaynta iyo shaqo ka eriga qaybaha shaqaale ee toos u hoos yimaada Maareeyaha Guud.
6. Wuxuu hab waafaqsan habraacyada iyo xeer-hoosaadka maamulka wakaalada ku shaqaaleeyaa, maamulaa, dalacsiiyaa, caydhiyaa shaqaalaha wakaalada ee ka baxsan kuwa lagu qeexay farqada 5aad ee sare;
7. Wuxuu hab waafaqsan qorshaha shaqo ee wakaalada iyo heeshiisyada qandaraas ku fasaxa kharashka lacageed ee lagu fulinayo shaqooyinka wakaalada islamarkaana ku dabagalaa meel marinteeda.
