PROCLAMATION

WHEREAS, there is an addition of funds tahat is not incorporated under the 2009 fiscal year budget appropriations made by the Somali Council and it is required for expenditure.

WHEREAS, there is unplaned works that could not have been foreseen in the 2009 fiscal budget appropriations and it is necessary to proclaimed Supplementary Budget to cover these works.

NOW, THEREFORE, in accordance with Article 49(3,A) of the Re Constitution of the Ethio Somali regional state, the Council hereby proclaimed as follows:

1, Short Title

This Proclamation may be cited as the "2009 Fiscal Year of Ethiopian Somali Regional Supplementary Budget Proclamation No. 171/2017"
