PROCLAMATION NO. 172/2017

THE 2009 FISCAL YEAR Second SUPPLEMENTARY BUDGET PROCLAMATION

WHEREAS, there is an additional funds tahat is not incorporated under the 2009 fiscal year budgetary appropriations made by the State Council and it is required for expenditure.

WHEREAS, there is unplanned works that could not have been foreseen in the 2009 fiscal year budget appropriations and found necessary to proclaimed a Supplementary Budget to cover this works.

NOW, THEREFORE, in accordance with Article 49(3,A) of the Revised Constitution of the Ethiopian Somali regional state, the State Council hereby proclaimed as follows:

1, Short Title

This Proclamation may be cited as "The Second 2009 Fiscal Year of Ethiopian Somali Regional State Supplementary Budget Proclamation No. 172/2017".
