Short Title This proclamation can be referred as "Somali regional state police commission establishing proclamation number 20/2002."</p> <p>2. Definition In this proclamation:-</p> <ol style="list-style-type: none"> "Constitution" means the revised Constitution of the Somali regional state "Commission" means Police Commission of the Somali Regional State. "State" means Somali Regional state.

Qod. 3^{aad} Aasaasid:-

- 1. Bayaankan waxaa lagu aasaasay komishinka Booliska ee Deegaanka Soomaalida oo hadda wixii ka dambeeya loogu yeedhi doono "Komishinka" ahna hay'ad dawli ah, iskeedna u madax banaan, isla markaana jiritaan sharci leh.
- 2. Komishinkani waxa uu hoostagayaa xafiiska xidhiidhinta Maamulka, Nabad-gelyada iyo Caddaalada.

፬. የኮሚሽኑ ዓላማ

ኮሚሽኑ የሚከተሉት ሥልጣንና ተግባሮች ይኖሩታል።

፩. የክልሉን ፀጥታና ሠላም ለማስከበር የሚያስችሉ ቅድመ እርምጃዎች የሚወሰዱበትን ሁኔታዎች ይቀይሳል።

4. "Cabinet" means an organ established under Art 57 of the revised constitution of the Somali Region.

5. "Region" means the Somali Region.

PART TWO

3. Establishment

1. The Somali region police commission here-in-after referred as to "the commission" is hereby established as an autonomous regional institution having juridical personality pursuant to this proclamation

2. The commission shall be accountable to Security Administration and Justice Coordination Office.

4. The Head Office of the Commission

The head office of the commission is in Jijiga, and it may have branch department in zones and weredas as it may be necessary.

5. The organization of the commission

- 1. Will have a commissioner and deputy commissioner appointed by the Cabinet upon the recommendation of the president of the region,
- 2. the other necessary staff.

6. The objective of the commission
The following are the objectives of the commission:

- 1. Creates a favourable condition for maintaining the peace and safety of the region.
- 2. Designs strategies for an advance prevention of criminal activities in the region.
- 3. Designs a strategy in which the society itself participate in prevention of the existence and the occurrence of crime in the region.
- 4. Takes the necessary action to minimize the occurrence of crimes in the region by collaborating with the concerned legal organs.

PART THREE

7. The power and duty of the commission

- 1. Designs advance strategies and actions, which enables to enforce the peace and safety of the region.

- 2. Wuxuu abuuraa nidaamyo lagaga hortagayo dambiyada.
- 3. Wuxuu daraasad ku sameeyaa sababaha keena dambiyada ka dhaca Deegaanka, isla markaana dajiya nidaamka wax looga qaban lahaa mustaqbalka.
- 4. Isagoo raacaya awaamiirta dawladda, ayuu is kaashi la sameeyaa komishinka dawlada dhexe iyo kuwa deeganaada kale ee dalka si loo xayiro dhaq-dhaqaaqyada dambiileyaasha.
- 5. Wuxuu diiwaan-geliyaa dambiyada ugu badan ee ka dhaca Deegaanka iyo talaabooyinka laga qaatay.
- 6. Wuxuu dajiya nidaamyo u suurto-geliya in kor loo qaado tayada Booliska.
- 7. Wuxuu sugayaa N/gelyada xafiisyada, hay'addaha iyo muwaadhiniinta ka shaqeyaa Deegaanka gudihisa ee aan u dhalan Deegaanka.
- 8. Wuxuu diyaariyaa xeerar iyo awaamiir ku wajahan nidaamka dabagalka dambiyada inuu yahay mid fududeeya dhawrista xuquuqda eedaysaneyaa sha.

Qod. 8^{aad} Awoodaha iyo Waajibaadada Komishineerka:-

Iyadoo Komishineerku fulinayo awoodaha iyo waajibaadyada komishinka ee lagu xusay bayaankan qodobkiisa 7^{aad}, waxa kale oo uu qabanaayaa hawlaha soo socda:-

- 1. Wuxuu soo diyaariyaa qorshaha iyo miisaaniyada komishinka ee wakhtiga fog. dhexe iyo kan dhaw, una gudbiyaa golaha hawl-fulinta, marka la ansixiyana hirgeliyaa.
- 2. Hab waafaqsan sharciga ku habboon ayuu shaqaalaha u shaqaaleeyaa, maamulaa, isla markaana shaqada uga eryaa.
- 3. Wuxuu si waafaqsan qorshaha miisaaniyada komishinka loo oggolaaday (ansixiyey) ugu hawl-geliyaa shaqada.
- 4. Wuxuu isagoo ka duulaya baahida shaqo ee komishinka u wakiishaa shaqaalaha komishinka awoodaha iyo waajibadkiisa, si waafaqsan sharciga.
- 5. Isagoo ka duulaya qaab-dhis-meedka komishinka ayuu warbixin ka siiya laamaha ay khusayso.

- ፮. የፖሊስ ኃይልን ብቃት ለማሳደግ የሚያስችሉ እርምጃዎች ይቀይሳል ።
- ፯. በክልሉ ውስጥ የሚንቀሳቀሱት የክልሉ ተወላጅ ያልሆኑ ግለሰቦች፣ ድርጅቶችና ሌሎች ተቋማት ፀጥታና ሰላም እንዲከበሩ ጥበቃ ያደርጋል ።
- ፰. የተከላኩ መብት ባገናዘበ ሁኔታ የወንጀል ምርመራ በተመለከተ ሕጎችና ደንቦችን ያዘጋጃል ።

የኮሚሽነሩ ሥልጣንና ተግባር

በዚህ አዋጅ አንቀጽ ፯ የተመለከተውን የኮሚሽነሩ ሥልጣንና ተግባር በአጠቃላይ እንጋገር እንደተጠበቀ ሆኖ ኮሚሽነሩ የሚከተለው ሥልጣንና ተግባር ይኖረዋል።

- ፩. የኮሚሽነሩን የረጅምና የአጭር ጊዜ የሥራ ፕሮግራምና በጀት ያዘጋጃል ሲፈቀድም በሥራ ላይ ያውላል ።
- ፪. አግባብ ባለው ሕግ መሠረት የኮሚሽነሩን ሠራተኞች ይቀጥራል፣ ያስተዳድራል እንዲሁም ያሰናብታል ።
- ፫. ለኮሚሽነሩ በተፈቀደለት በጀትና የሥራ ፕሮግራም መሠረት ገንዘብ ወጪ ያደርጋል ።
- ፬. ኮሚሽነሩ ለኮሚሽነሩ የሥራ ቅልጥፍና በሚያስፈልግ መጠን ሥልጣንና ተግባርን በክፍል ለኮሚሽነሩ ሠራተኞች በውክልና ሊያስተላልፍ ይችላል ።
- ፭. ስለ ኮሚሽነሩ የሥራ እንቅስቃሴ ለሚመለከተው አካል ሪፖርት ያቀርባል ።

- 2) Makes advance preparation to prevent criminal act.
- 3) Makes studies on the causes of criminal acts and designs a way of preventive solution for the future.
- 4) Deters the movements of criminals by collaborating with the Federal Police Commission and Regions.
- 5) Registers the frequently occurred crimes and the actions taken by.
- 6) designs actions, which enables to build the capacity of police force.
- 7) Provide the necessary protection for the enforcement of peace and safety toward individuals, organizations and other institutions. operating in the region and which are non-regional
- 8) Prepares rules and regulations concerning the facilitation of criminal investigation, by perceiving the right of the defendant.

8. The Powers and Duties of the Commissioner

The commissioner will have the following power and duty, with the power and duty of the commission indicated in Article 7 of this proclamation.

- 1) Prepares the long and short term programmes and budget of the commission and implement upon approval.
- 2) Employ, administer and dismisses the employees in accordance with pertinent laws.
- 3) Effect payments in accordance with the budget and work programme approved for the commission.
- 4) The commissioner may delegate part of his power and duty to the workers of the commission when the commission needs a support for its working activity.
- 5) Present a report on the activities of the commission.

Qod. 14^{aad}- Muddada dhaqan-galka bayaankan:-

Bayaankani wuxuu dhaqan-galaya laga bilaabo maalinta uu ku soo baxo Dhol Gazettea.

- 7) represents the commission in all its dealing with the third party.
- 8) Performs other duties designated by justice institution.

PART FOUR

Miscellaneous provisions

9. Budget

- 1) The budget of the commission shall be allotted by the state
- 2) Donation that may be found from other body.

10. Books of Account

- 1) the commission shall keep complete and accurate books of accounts.
- 2) The books of accounts and financial documents of the commission shall be inspected annually by the chief auditor or by his assigned Auditors.

11. Duty to co-operate

any person is obliged to co-operate in the performance of the commission provisions of this proclamation.

12. Inapplicable laws

Any laws or regulations that contravenes this proclamation shall be inapplicable.

13. a power to issue directives

The commission has a power of issuing directives to make this proclamation effective.

14. Effective date

This proclamation shall be effective from the date of its publication on Dhol Gazettea.
