 THE PROCLAMATION TO PROVIDE THE ESTABLISHMENT OF DISASTER PREVENTION AND FOOD SECURITY BUREAU.
 WHEREAS; it's necessary to reorganize the executive organs of the Region in a manner that enables to govern in efficiently and implement the economic and social development principles of the Region and to this effect, to device strategies so as to provide a full service to the people of the same thereof,
 WHEREAS, natural and man made catastrophe occurs consecutively in the Region.
 WHEREAS, it is found necessary to establish a Disaster Prevention and Food Security Bureau, so as to remove and manage the disaster in the Region NOW, THEREFORE, the council of the Region in accordance with Article 49 (3) (A) of the Revised Constitution of the Region, it is hereby proclaimed as follows.

PART ONE

General

1 Short Title

This proclamation may be cited as the “Proclamation to provide the Establishment of Disaster Prevention and Food Security Bureau of Somali Regional State Proclamation No. 27/2002.”

2. Definition

Unless the context require otherwise in this proclamation:

- 1) “Bureau” means the Disaster Prevention and Food Security Bureau of Somali Regional State;
- 2) “State” means the Somali Regional State;
- 3) “Cabinet” means an organ established (specified under Article 57 of the Revised Constitution of the Region.
- 4) “Region” means the Somali Region.

PART TWO

3. Establishment

- 1) The Disaster prevention and Food Security Bureau of the Somali Region herein after referred as to the “Bureau” is hereby established as an autonomous public institution having juridical personality under this proclamation
- 2) The Bureau shall be accountable to the pastrolist and Rural Development Coordination office.

4. Head office

The head office of the Bureau shall be Jijiga and it may have branches in the zones and woreda of the Region as may be necessary

1. Wuxuu sahlaa sidii Deegaanku xagga cuntada uu isku filnaansho u gaadhi lahaa.

2. Wuxuu ka hortagga masiibooyinka, isagoo meesha ka saaraya waxyaabaha sababa masiibooyinka.

3. Wuxuu dhis awooda lagama maarmaanka u ah yareynta khasaaraha ay masiibooyinku sababi karaan.

4. Wuxuu hubiyaa in Dadka ay masiibooyinku asiibeen wakh-tiga ku habboon kaalmda la gaadhsiiyay.

Awoodaha iyo waajibaadyada xafiisku waa sidan hoos ku cad:-

1. Wuxuu dejiyaa xeeladaha lagaga hortagayo iyo tabaha deegaan ee u diyaar garowga masiibooyinka, marka la ansiiyana meel marintiisa dabagalaa.

፩. የክልሉ የአደጋ መከላከያ ፖሊሲና የዝግጁነት ስልቶች ያዘጋጃል ። ሲፈቅድም በሥራ ላይ መዋላቸውን ይቆጣጥራል ፤

፪. ከዚህ በፊት በተከሰቱት አደጋዎች ልምድ መሠረት በማድረግ አደጋን ለወደፊቱ ለመከላከል የሚረዱ ስልቶች ይቀይሳል ፤

፫. ከሚመለከታቸው አካላት ጋር በመተባበር የአደጋ መንስዔዎችን አስቀድሞ ያጠናል የቅድሚያ ማስጠንቀቂያ ሥርዓትን ያዘረጋል ፤

5. Organization of the Bureau

1) The Bureau shall have a Head & Deputy head to be appointed by the cabinet upon the recommendation by the president &

2) Other necessary staff.

6. Objectives

The Bureau shall have the following objectives;

1) Shall set up conditions in the region including the means for sufficient food capability of the Region

2) To prevent disasters by way of removing the basic causes thereof

3) To build in advance, the capacity necessary to alleviate the extent of damages that could be caused by disasters.

4) To ensure the timely arrival of the necessary assistance to the victims of disasters.

PART THREE

7. Powers & duties of the Bureau

The Bureau shall have the powers and duties given below;

1) To formulate the Region disaster prevention policy and preparedness strategy to follow up its implementation upon approval;

2) To formulate strategies to prevent future disasters by way of studying previous disasters;

3) In cooperation with concerned organs, to undertake prior studies on the causes of disaster, set up early warning systems for early warning

4) In cooperation with concerned organs, to determine the magnitude of disaster together with measure to be taken in connection therewith and officially declare area of disaster;

5) In accordance with directives issued to it by the government, request and receive any form of assistance from federal government and other governmental organizations operating in the Region.

Isagoo la kaashanaya hay'addaha ay khusayso ayuu dib u dajiyaa dadka masiibooyinku asiibeena.

Wuxuu oggolaansho siiyaa, iskuna dubaridaa, isla markaana kormeeraa hawlaha samafalka iyo horumarinta ee Hay'addaha kaalmooyinka biixiyaa ay wadaan, kana warbiixiyaa waxqabadkooda.

Wuxuu diyaariyaa xeerarka iyo awaamiirta ku wajahan nidaamka dabagalka iyo ababulka hay'addaha wadaniiga ah ee ku hawlan, isla markaana raba inay ka qaybqaataan barnaamijiyada horumarinta iyo la dagaalanka saboolnimada.

Wuxuu abuuraa xaaladaha ku habboon sidii deegaanku u gaadhi lahaa isku filaansho xaga cuntada.

Kaalmooyinka caawimo ee Bulshada loo qaybinayo ayuu ku meel marin karaa qaab iskaa wax u qabso ah.

Waa mulkiile hanti, wuxuu galaa heshiisyo, magaciisa wax buu ku dacwayn karaa, sidoo kale isna waa la dacwayn karaa.

6) To register all forms of assistance received from domestic and foreign sources and cause the distribution of same to the people being affected;

7) To inform the public through the mass media of the type, volume and utilization of assistance received from domestic and foreign sources;

8) In cooperation with the appropriate organs, to rehabilitate victims of disaster;

9) Issue certificate of permit as well as coordinate the relief and development activities carried out by non governmental aid organizations, report on their performance;

10) Prepares laws and directives on the system of follow up on the mobilization of civil society and indigenous organization operating in the Region on the development and poverty eradication strategy.

11) Extend a system of building the Region's self food sufficiency capacity;

12) Execute the distribution of relief to the community by way of food for work programme;

13) Own property, enter into contract, sue and be sued in its own name;

14) Perform such other duties as to enhance the achievement of its objectives.

8. Powers and Duties of the Bureau Head

The Bureau head shall have, in addition to the powers and duties given to the Bureau under Article 7 of this proclamation, the following powers and duties.

1) Prepare & submit to the cabinet the long, medium and short term plan and budget of the Bureau, implement the same upon approval.

4. Si sharci ah ayuu magaca xafi- iska akownti bankiga ugaga furi una dhaqdhaqaajin.
5. Hadba sida ay baahidu tahay ayuu awoodaha iyo waajibaa- dyada bayaankan lagu siiyey qayb ama dhamaan shaqaal- aha xafiiska u wakiishaa.
6. Qaab-dhismeedka xafiiska ayuu daraasaad ku sameeyaa Golaha hawl-fuintana u soo bandhigaa, marka la ansixiy- ana ku dhaqmaa.
7. Waxqabadka xafiiska ayuu la- amaha ay khusayso warbixin ka siiyaa.
8. Wuxuu matalaa xafiiska marka lala macmiiloonayo cid saddexaad.
9. Waxa uu qabtaa hawlaha kale ee ay Golaha hawl-fuli- nta iyo xafiiska xidhiidhinta horumarinta xoolo dhaqat- ada iyo reer miyigu u xilsa- ran.

- 5) Delegate his powers and duties vested to him under this proclamation to the employee of the Bureau. Partially or fully as may be necessary;
- 6) Study and submit to the cabinet the organizational structure of the Bureau, implement the same upon approval;
- 7) Provide a report on the performance of the Bureau to the concerned organs;
- 8) Represent the Bureau in all its dealing with third parties;
- 9) Perform such other activities designated to him by the cabinet and coordinating office for pas- toralist and Rural development office.

Miscellaneous provisions.

9. Budget
 - 1) The Budget of the Bureau shall be allocated by the state.
 - 2) Any financial assistance ob- tained from other sources.
10. Books of accounts
 - 1) The Bureau shall keep complete and accurate books of accounts.
 - 2) the Books of accounts and financial documents of the Bureau shall be audited annually by the auditor General or auditors desig- nated by him
