Art. 2-Definition:-

Unless the context requires otherwise on this proclamation;

1. "Bureau" means Bureau of labour and social affairs of the Somali Regional State established herein.
2. "State" means the Somali Regional State.
3. "Cabinet" means an organ established under Art. 57 of the revised constitution of the region.
4. "Region" means the Somali Region.
5. "Labour" means an employee governed (Administered) by the labour proclamation No. 42/1993 of the federal government of Ethiopia.

PART TWO

Art.3- Establishment

1. The Somali Regional Bureau of Labour and social affairs established herein after referred as "Bureau" is hereby established as an autonomous public institution of the region with its own juridical personality.
2. The Bureau shall be accountable to the office of the president of the region.

Art. 4-Head Office

The head office of the Bureau shall be in Jijiga and it may have branches in the zones and woredas as may be necessary.

Art. 5- Objectives:-

The objective of the Bureau is to implement, enforce and coordinate policies, programs and laws relating to labour and social affairs.

Art.6 -Organization of the Bureau

- The Bureau shall have;
- 1. A head to be appointed

Wixii la xidhiidha shaqada iyo Arrimaha bulshada ee uu bayaan-ka. 14/1987 ee qeexida awoodaha iyo waajibaadyada hay'addaha fulinta ee dawladda deegaa-nka Soomaalida, qodobkiisa 18 uu siinayey xafiiska shaqada, arrimaha bulshada, ka hortagga iyo u diyaar-garawga masiibooyi-nka, waxaa hadda wixii ka damb-eeya bayaankani ku wareejina-yaa xafiiska shaqaalaha iyo arri-maha bulshada.

Qod. 13^{aad}- Muddada Dhaqan-galka:-
Bayaankan wuxuu dhaqan-galayaa laga bilaabo marka uu ku soo baxo dhool Gazeta.

Art. 10- *Books of accounts*

1. The Bureau shall keep completed and accurate books accounts.
2. The Bureau's Books of account and financial documents shall audited annually by the auditor General or by auditors designated by him.

Art. 11 - *In applicable laws*

any laws custom and directives that contravene this proclamation relate to matters provided for here shall be in applicable.

Art. 12- *Transfer of Rights and Obligations*

The Rights and obligations of disaster prevention and preparedness labour and social affairs Bureau specified in Art. 18 of proclamation No. 14/1995 as relates to labour & social Affairs is hereby transferred to Bureau of labour and social affairs.

Art. 13 - *Effective Date*

This proclamation shall enter force upon its publication on D Gazetta.
