Part one
General

Art 1. Short Title

This proclamation may be cited as ‘‘The Re-establishment proclamation of Judicial Administration Commission of Somali regional state’’ proclamation No 37/1994.

Art 2. Definition

Unless the context requires otherwise, in this proclamation;

1. ‘‘ council ’’ means the legislative organ of Somali region.
2. ‘‘ commission ’’ means regional and zonal judicial administrative commission
3. ‘‘ Judges ’’ means a person proposed by the commission and approved by the council, as a judge.
4. ‘‘other nominees’’ means registrars, private lawyers, legal experts and department heads nominated by the judicial administration commission
5. ‘‘ inspection’’ means inspection and supervision department establishment by regional supreme court.

Art 3. Establishment

This proclamation establishes judicial administration commission hereafter called ‘‘ the commission ’’

Chapter two

Structure, powers and duties of the commission

Art 4. structure of the commission

The commission shall have;

1. a regional judicial administration committees founded at regional supreme court head quarter
2. a zonal judicial administration committees founded at zonal high courts of the region
1. Art.5. Members of regional commission members of regional commission shall consist of;
 - a) the president of supreme court = chairperson=
 - b) the vice-president of supreme court = member=

 - J) laba xubnood oo ka tirsan garsoorayaasha heer gobol iyo laba xubnood oo ka tirsan garsoorayaasha heer degmo oo ay garsoorayaashu iska soo dhexdooranayaan.
- 2. Xoghayaha guddiga waxa iska soo dhexdooranaya xubaha guddiga.
- 3. marka uu shirguddoonku maqanyahay xubnaha guddiga, ee garsoorayaasha ah oo uu magacaaba shirguddoonku ayaa wada-ya hawsha shirguddoonka.

- c) two judges from regional supreme court judges selected by the chairman and approved by the commission
- d) Two members who are not members of the executive organ from regional council nominated by the speaker of the house and.
- e) two judges from first instance courts judges elected by the judges.
- f) A member from lawyers association elected by association members.
- 2. In the absence of the chairman, the vice-chairman of the supreme court shall serve as chairman.
- 3. judicial administration department head in the supreme court shall seat commission's meetings with no vote right and shall serve as secretary of the commission .
- 4. dual membership of regional and zonal commission is prohibited.

Art 6- members of Zonal commission

- 1. zonal commission members shall consist of :-
 - a) the president of zonal high court who is the chairman
 - b) member from regional council nominated by the speaker of the house who is not member of executive body and elected from the concerned zone
 - c) two zonal high court judges and two first instant judges elected by judges of the concerned high court .
- 2. the secretary of the zonal commission will be elected from among commission members.
- 3. In the absence of zonal commission chairman, any commission member who is judge and nominated by the chairman shall preside.

Art 7- powers & duties of regional commission

The regional commission shall have the following powers and duties:--

4. Wuxuu soo saaraa, dhaqangaliya, xeerar ku saabsan meelaynta, mushaarka, gunooyinka daawaynta, dalacsiinta, tababarada, badalka, shaqo ka eriga, gudashada waajibaa-dyada iyo anshaxa garsoora-yaasha.
5. wuxuu soo saraa, dhaqanga-liyaanna, xeerar ku saabsan magacaabidda. Dalacaada, bada-laada, mushaarka, shaqo ka eriga, gudashada waajibaadka iyo anshaxa xubnaha kale ee magacaabista ah.
6. marka ay jirto baahi deg-deg ahi ama jago ah ugu sikumee-lagaadh ah ka heer saraysa shaqadiisa.
7. marka ay lagama maarmaan noqoto in Garsoore heer degmo loo dalacsiyo heer gobol ayuu u bandhigayaa oo uu fikirkiisa waydiinayaa guddiga maamul ka garsoorka ee faderaalka sida ku cad. qod 81 (4) ee dastuur-ka faderaalka.
8. Waxa uu baadhaa ama sababaa in uu dabagalku soo baadho, islamarkaana ka go'aan gaadhaa cabashooyinka iyo eeday-maha dhanka ka ah garsoora-yaasha iyo xubnaha kale ee magacaabista ah.
9. waxa uu darsaa oo uu go aamiyaa isagoo sharciga waa-fajinaya qaab hawleedka max-kamadaha.

1. the commission shall select and opinion from among candidate judges pro-posed by the supreme court president after the approval of regional council those who fulfill conditions laid down article 13 of this proclamation
2. Allows temporary job entrance of appointed judges before the approval of the and suspend council.
3. Appoints other nominee members in accordance with the law.
4. Issues and implements rules concerning the appointment, salary pro-motion, training, transfers, dismissal , performance judicial ethics and medical allowan-ces.
5. Issues and implement rules concerning appointment, promotion transfer salary dismissal performance ju-dicial ethics of other nomi-nee members
6. When it deemed necessary may Temporary assign higher post to the judge.
7. submits and asks opinion from federal judicial administration commission when it is necessary to give promotion first instant judges to high court judge pursuant to article 81(4) of federal constitution.
8. inspects or causes to inspect complaints against judge and other nominee mem-bers
- 9 makes assessments and decides the working sys-tem of courts in accordance with the law

- 10. waxa uu dhagaystaa racfaanka laga soo qaato go'aanada ay guddiga heer gobol ka gaadho cabashooyinka iyo eedaymaha dhanka ka ah garsoorayaasha iyo xubnaha kale ee magacaabista ah.
- 11. Waxa uu baadhaa ama uu sababaa in dabagalku soo baadhno, oo islamarkaana u goaamiyaa si waafaqsan Qod- 67(4) ee destuurka DDS arimaha loo horkeeno sida ku cad Qod 14 aad ee bayaankan. Waxuuna Shaqada ka joojin karaa garsoore uu arintiisa go'aan ka gaadhayo golaha xildhibaanadu.

Qod. 8^{aad}. Awoodaha iyo waajibaadyada shirguddoonka guddiga heer Deegaan
 Shirguddoonka waxa uu yeelanaa awoodaha iyo waajibaadyadan soo socoda:

- 1. Wuxuu hogaamiyaa, kormeraan xafiiska xoghaynta Guddiga,
- 2. wuxuu isugu yeedhaa, gudoomiyaana kulamada guddiga;
- 3. Wuxuu diyaariyaa islamaar kaana golaha xildhibaanada u gudbiyaa taariikh nololeedka xubnaha loo magacaabay garsooranimo si waafaqsan bayaa- nkan;
- 4. Iyadoo qaybtaa 3aad ee Qod- obkani sidiisaa ahaanayo, ayuu xubnaha kale ee magacaabista ee uu soo xushay u bandhigayaa guddiga;
- 5. Wuxuu sababaa in dabagalku soo baadhno cabashooyinka loo soo gudbiyo iyo eedaymaha dhanka ka ah garsoorayaasha iyo xubnaha kale ee magacaabista ah, hadii uu lagamaar- maan u arkana wuxuu arinta u gudbiyaa guddiga
- 6. Wuxuu darsaa qaab-hawleedka maxkamadaha, waxuuna war- bixin uu talo bixintiisa soo raaciyay ugudbinayaa guddiga. Wuxuuna dhaqan galinayaa goaanka ay guddidu qaadata;
- 7. Wuxuu isagoon isugu yeedhin ugu diraa si kumeelgaadh ah garsoore ama xubnaha kale ee magacaabista ah hawl u dhi- ganta ama ka heer saraysa hawshiisa marka ay timaaddo xaalad dagdeg ahi. Haseyee- shee waxa uu goaankiisa soo hordhigayaa oo uu ka ansixinayaa guddiga.
