PROCLAMATION NO. 49/1996
REESTABLISHMENT
PROCLAMATION OF SOMALI STATE
POLICE COMMISSION

Whereas, it is has become necessary to have a well organized and strong civil police institution which is faithful to the constitution of the region and respectful to the laws enacted in accordance with the constitution, equipped with training required for his profession and serves the public, ensures the observation of human and democratic rights and maintains peace and welfare of the public.

Now, therefore, in accordance with Article 49(3,A) of the revised constitution of the region, it is hereby proclaimed as follows;

Part one
 General

Art 1. Short Title
 This proclamation may be cited as the " the Somali regional state police commission reestablishment proclamation no 49/1996

Art 7. Powers and Duties of the Commission

The commission shall have the following powers and duties;

1. prevent and investigate crimes that fall under the jurisdiction of the regional courts.

2. prevent any activities in violation of the constitution that may endanger the constitutional order.

3. prevent violence against public peace, hooliganism, terrorism, trafficking in and transferring of drugs.

4. prevent crimes against the interest and institutions of the regional government.

5. give security protection to higher officials of the regional government and other dignitaries in the region.

6. executes orders and decisions of the courts

7. executes orders issued by the General prosecution of the region in regard to investigation of crimes.

8. issue a certificate of No criminal record .

9. conducts studies to enhance crime prevention and investigation activities and to enable that the efficiency and serves of the police profession of the region in co-operation with concerned bodies.

10. collect and analyze criminal data and statistics at region wide level.

11. exchange information and undertake coordinated activities with security organs and engage with them in research and training in a mutually supportive manner.

Art 10 Powers and Duties of the Commissioner

1. the commissioner shall be accountable to the co-ordination bureau and shall direct and coordinate the overall activities of the commission.

2. without prejudice to the generality of sub-article 1 of the article, the commissioner shall;

a) Execute the regulations of the regional police .

b) Submit the annual work plan and budget of the commission to the concerned organs and implement the same upon approval by the government;

c) Render a final decision on appeals lodged against the decisions of regional police complaint hearing organ and that of the disciplinary committee.

d) Effect expenditure in accordance with the budget approval for commission.

e) Cause studies to be made in regard to the organization and building the capacity of the commission on the improvement of crime prevention and investigation activities; as well as on police service standardization.

F) effort in having with the federal and other regions police commission by establishing relation and seek ways to enhance the capacity of the commission.

Art 11 Powers and Duties of Deputy Commissioner

- b) follow up part of the commission's department by sharing function in accordance with the structure of the commission.
- c) Act on behalf of the commissioner in the absence of latter.
- d) Discharge other duties which may be specifically entrusted to him by the commissioner.
- e) The deputy commissioner shall be accountable to the commissioner.

Art 12. Budget
The regional government shall allocate the budget of the commission.

Art 13 books of accounts

- 1. the commission shall keep complete and accurate books of accounts.
- 2 The Books of accounts & financial documents of the commission shall be annually audited by the Auditor General or Auditors designated by him.

Part Three
Administration of the Regional Police

Art 16. Terms of Service

- 1. any police officer shall be employed for seven years obligatory service, particulars for it's implementation shall be determined by law.
