1. Short title

This proclamation may be cited as " the proclamation to amend proclamation no 18/94 for the reorganization of executive organs regional state'' proclamation no 54/1998.

2. Definitions

1. " Bureau" means Bureaux established under Art 4 of proclamation no 18/94.
2. "executive organs" means an organ stipulated under Art 57 of the revised constitution.
3. "co-ordination bureaux" means bureau established under Art 4 of proclamation no-18/94 and powered to supervise and lead bureaux land other insti - tutions of the state.

Art 3 Amendment

Art 3 of proclamation no18/1994 is deleted and replaced or amended as follows to be members of regional executive council;

2. vice president of the region
