There for the accordance with Somali Regional revised regional constitution the Somali Regional council is proclaimed as follows: <u>Part One</u> <u>General</u> 1. <u>Short Title</u> This proclamation may cited as "the cancellation of the proclamation No. 8/91 of the lease and Urban land Administration of Somali Regional State proclamation No. 89/2003". 2. <u>Cancellation</u> Somali Regional State lease and Urban land Administration proclamation No. 8/91 here is cancelled by this proclamation . 3. <u>Effective Date</u> This proclamation shall come into force as the date approved by the Council of the Region.
