Short Title</p> <p>This proclamation may be cited as the "Somali Regional State of Ethiopia Courts establishment (Amendment) Proclamation No. 152/2016.</p> <p>2 :-Amendments</p> <p>The regional Courts establishment Proclamation No. 9/1991 is hereby amended by the following articles of article. 8, 9, 22 and 29 hereof.</p>

1. 4. የከፍተኛ ፍርድ ቤት የዳኝነት ሥልጣን

የዞኑ ከፍተኛ ፍርድ ቤት ግምታቸው ከአራት መቶ ሺህ አንድ ብር (400,001) ብር በላይ በሆኑ የሚንቀሳቀሱና የማይንቀሳቀሱ ንብረቶች በሚመለከቱ ክልላዊ ጉዳዮች ላይ የመጀመሪያ ደረጃ የዳኝነት ስልጣን ይኖረዋል።

5. የአዋጁ አንቀጽ 22 እንደሚከተለው ተሻሻሏል፡-

የክልሉ ጠቅላይ ፍርድ ቤት ተጠሪነታቸው ለጠቅላይ ፍርድ ቤት ፕሬዝዳንት የሆነ ሦስት ምክትል ፕሬዝዳንቶች ይኖረዋል። ይኸውም፡-

3 :- Civil Jurisdiction of the court

1. The woreda court shall have first instance jurisdiction over civil cases involving an amount not exceeding Birr four thousand (400,000) and over civil cases the value of which cannot be expressed in money.
2. Appellate cases over decisions of the social courts
3. Cases regarding employment and employer relationship
4. Appeals against the Administrative Tribunal of regional governments and servants.
5. Cases regarding change of name.

4 :- Jurisdiction of the Federal High Court

The zonal high Court shall have exclusive first instance jurisdiction over civil cases of regional governments involving an amount exceeding Birr four hundred thousand (400,001);

5 Article 22 of the proclamation shall be amended as follows :

The Regional Supreme Court shall have the following three Vice-Presidents accountable to the President of Supreme Court

- 1) Vice-President for criminal matters
- 2) Vice-President for civil matters
- 3) Vice-President for Administrative matters

Article 6. The following 23 is added to the proclamation existing articles one step back:-

23'' Powers and duties of Presidents:-

1) Powers and duties of President for criminal cases:-

A. administer and preside over the benches of Criminal Division

B. may preside over any court division benches of Criminal Division

C. Prepare the statistics of criminal cases

D. Shall follow up and ensure proper execution of criminal cases.

E. submit to the President of the Supreme Court periodic report on the criminal activities of the Court;

F. Perform such other duties as may be entrusted to him by the President of the Supreme Court

2) Powers and duties of President for civil matters:-

A. administer and preside over the benches of Civil Division

B. May preside over any court division benches of Civil Division

- F. Perform such other duties as may be entrusted to him by the President of the Supreme Court.

3) Powers and duties of the President for administrative matters shall be :-

- A. Administer and organize all administrative matters of the court.
- B. Administer personnel of the Court.
- C. Shall administer and coordinate the administrative and financial matters of the Court.
- D. submit to the President of the Supreme Court periodic reports on the administrative matters.
- E. Perform such other duties as may be entrusted to him by the President of the Supreme Court.

7:- Annual Leave of Judges

Leaves of Judges shall be governed in accordance with Articles 27-41 of the civil service proclamation 38/1995.

8:- Pending cases

All unresolved Cases pending in the Regional Court shall be referred over in accordance with the Proclamation.

9:- Effective Date.

This Proclamation shall come into force as of the 27th day of February 2016
