Proclamation No 153/2016
THE PROCLAMATION TO ELABORATE THE PROCEDURE FOR THE IMPLEMENTATION OF RENAISSANCE SYSTEM OF SOMALI REGIONAL STATE OF ETHIOPIA

Whereas, for the implementation of Renaissance plans, security and development undertakings of Somali Regional State of Ethiopia Has made necessary to contract out a responsible and healthy ideology free from nepotism, tribalism and bias.

Whereas, it is found necessary to ban out the forgoing system Ralied on a culture of narrow ideology that has negative impact on the need for achieving a system with good governance, privlence of development, peace and justice.

NOW, THEREFORE, the state council in accordance with Article 49(3, A) of the revised Constitution of the Somali Regional State of Ethiopia, hereby proclaimed as follow:-

PART ONE
General

1. Short Title

This Proclamation may be cited as the “The Proclamation to elaborate the procedure for the Implementation of Renaissance system, Proclamation No. 153/2016”

Qodobka 2^{aad}. **Qeexid**

Hadaan haboonaanta weedhu siinin macno kale, bayaankan dhexdisa;

1. **“Guddoomiye ama Maayarka dib u curasho”** Waxaa loola jeedaa Guddomiye ku xigeenka ama Maayar ku xigeenka ay xukumadu u magacwdo degmo, Tuulo ama maamul magaalo lehna awood guddoomiyenimo ama Maayar/
2. **“Deegaan”** Waxaa loola jeedaa Dawlada Deegaanka Soomaalida Itoobiya
3. **“Mas’uulada”** Waxaa loolaa jeedaa mas’uulada magacaabista ah ee ka hawl gala heerasha kala duwan ee qaab dhismeedka degmo, maamul magaalo iyo tuulo.
4. **“Maamul Magaalo”** Waxaa loola jeedaa Maamulada magaalooyinka ee lagu aasaasay hab waafaqsan bayaanka aasaaska magaalooyinka DDSI.
5. **“Tuulo”** Waxaa loola jeedaa sida uu dhigayo Dastuurka dib loo habeeyay ee DDSI qaab dhismeedka ugu hooseeya ee DDSI.

Qodobka 3^{aad}. **Xadka Dhaqangalka Bayaanka**

Bayaankan wuxuu dhaqan gal ku yahay Dhamaan qaab dhismeedyada kala duwan ee heer Degmo, heer maamul magaalo iyo heer Tuulo.

Qodobka 4^{aad}. **Habka dhaqan galinta Dibu curashada**

1. Marka laga reebo Af-hayeenada iyo Af-hayeen ku xigeenada golyaasha degmooyinka, Maamul magaalooyinka iyo tuulooyinka, waxay xukumadu isku badali kartaa islamarkaana goob kale u geyn kartaa dib u curasho dhamaan mas’uuliyiinta heer Degmo, Maamul Magaalo iyo heer Tuulo.

2. **ትርጓሜ**

የቃሉ አግባብ ሌላ ትርጉም የሚያስጥ ካልሆነ በስተቀር በዚህ አዋጅ ውስጥ፡-

1. **«የህዳሴው ሊቀመንበር ወይም ከንቲባ»** ማለት የወረዳ ሊቀመንበርነት ወይም የከተማ አስተዳደር ከንቲባነት ወይም የቀበሌ ሊቀመንበርነት ሥልጣን ያለው ሆኖ በክልሉ መንግሥት የሚሾም የወረዳ የምክትል ሊቀመንበር ወይም ምክትል ከንቲባ ነው፤
2. **«ክልል»** ማለት የኢትዮጵያ ስማሌ ክልላዊ መንግሥት ነው፤
3. **«የሥራ ኃላፊዎች»** ማለት በተለያዩ የቀበሌ አስተዳደር እርከኖች የወረዳ፣ የከተማ መስተዳድሮች የተሰማሩ (የተመደቡ) ተሸዋሚ የሆኑትን የስራ ኃላፊነት ነው፤
4. **«የከተማ መስተዳደር»** ማለት በኢትዮጵያ ስማሌ ክልላዊ መንግሥት የከተሞች አደራጃጀት ሥልጣንና ተግባር ለመወሰን ባወጣው አዋጅ መሠረት የተቋቋመ የከተማ መስተዳደር ነው፤
5. **«ቀበሌ»** ማለት በተሻሻለው የክልሉ ህግ-መንግሥት መሠረት የኢትዮጵያ ስማሌ ክልላዊ መንግሥት የታችኛው የአስተዳደር እርከን ነው፤

3. **የአዋጁ የተፈጻሚነት ወሰን**

ይህ አዋጅ በማንኛኛውም በወረዳ፣ በከተማ መስተዳድሮች እና በቀበሌ ደረጃ ባለው የአስተዳደር እርከኖች ላይ ተፈጻሚ ይሆናል፤

4. **ስለ ህዳሴው ለውጥ አፈጻጸም ሥርዓት**

1. የወረዳ፣ የከተማ እና የቀበሌ ምክር ቤቶች አፈ-ጉባኤዎች እና ምክትል አፈ-ጉባኤዎች በስተቀር ባለው ሌሎች የሥራ ኃላፊዎችን የክልሉ መንግሥት በህዳሴው አማካይነት የወረዳ፣ የከተማ አስተዳደሮችና የቀበሌ የሥራ ኃላፊዎች ዝውውር በሚደረግ ከቀድሞው የሥራ አካባቢ ወደ ሌላ አካባቢ ሊቀይር ይችላል፤

2:- **Definitions**

Unless the context requires otherwise in this proclamation:-

1. **“Renaissance chairman or mayor”** shall mean the deputy chairman or deputy mayor whom the government appoints to administer the woreda, kebeles or city Administrations, entrusted the power of chairmanship or mayors.
2. **“Region”** means the Somali Regional State of Ethiopia.
3. **“Officials”** shall mean any Officials appointees serving in various Administrative Hierarchies organized at Woredas, Municipalities and Kebele level,
4. **“City Administration”** means City Administrations established in accordance with in the proclamation to provide the organization and establishment of urban centers in the Somali regional state of Ethiopia.
5. **“kebele”** shall mean the lowest administrative hierarchy of the state pursuant to the revised constitution of Somali regional state of Ethiopia.

3. **Scope of Application of the Proclamation**

This proclamation shall be applicable to all Administrative Hierarchies organized at Woredas, Municipalities and Kebele level,

4. **Procedure for Implementation of Renaissance System**

1. Except the Speakers and Deputy Speakers of the Woredas, city administrations and kebele Councils, the state government may reallocate and transfer to another situate all officials at woredas, city and kebele Administrations, on the grounds of Renaissance system.

- 2. Iyadoon wax loo dhimayn Nidaamka doorasho ku imashada guddoomiyaha degmada, Maayarka magaalada ama guddoomiyaha tuulada , ayaa marka ay xukumadu lagama maar maan u aragto waxaa la magacaabi karaa guddoomiye dib u curasho degmo, Maayar dib u curasho maamul magaalo ama guddomiye dib u curasho Tuulo
- 3. Guddoomiyaha ama Maayarka dib u curasho wuxuu noqonayaa guddoomiye ku xigeen leh awoodaha iyo waajibaadka guddoomiyaha ama Maayarka.
- 4. Degmadu waxay yeelan guddoomiye ku xigeen mas'uul ka noqda mid kamid ah xafiisyada heer degmo.

Qodobka.5^{aad} Shuruucda aan dhaqan galka lahayn

Sharci, hab dhaqan shaqo ama talaabo kasta oo maamul oo ka hor imanya qodobada byaankan waa waxba kama jiraan.

- 2. የወረዳው ሊቀመንበር፣ የከተማ አስተዳደር ከንቲባ ወይም የቀበሌው አስተዳዳሪ በምርጫ የማይሰየምበት ሥርዓት እንደተጠበቀ ሆኖ የክልሉ መንግሥት አስተዳደር ሆኖ ሲያገኘው የወረዳ የህዳሴ ሊቀመንበር በሚጠራ ምክትል ሊቀመንበር፣ የከተማ አስተዳደር የህዳሴ ከንቲባ ወይም የቀበሌ የህዳሴ አስተዳዳሪ ሊሾም ይችላል፤
- 3. የህዳሴ ለውጥ ሊቀመንበር ወይም ከንቲባ የሚሆነው/የሚይዘው/ የወረዳ ሊቀመንበርነት ወይም የከንቲባነት ሥልጣን ያለው የወረዳ ምክትል ሊቀመንበር ወይም ምክትል ከንቲባ ይሆናል፤
- 4. ወረዳዎች የወረዳውን ሴክተር መ/ቤት አንዱ የሚመራው /ኃላፊ/ ምክትል ሊቀመንበር ይኖራቸዋል፡፡

5. ተፈጻሚነት ስለማይኖራቸው ህጎች

ከዚህ አዋጅ ጋር የሚቃረን ማንኛውም ህግ፣ ደንብ ወይም ልማዳዊ አሰራር በዚህ አዋጅ በተሸፈኑ ጉዳዮች ላይ ተፈጻሚነት አይኖረውም፡፡

6. ደንብ ስለማውጣት

የክልሉ አስፈጻሚ ምክር ቤት ለዚህ አዋጅ አፈጻጸም የሚረዱ ደንቦችን ሊያወጣ ይችላል፡፡

7. አዋጁ የሚፀናበት ጊዜ

ይህ አዋጅ በክልሉ ዶል ጋዜጣ ታትሞ ከወጣበት ቀን ጀምሮ የፀና ይሆናል፡፡

- 2. Without prejudice to the procedure lay down that The Woreda Chairman, city mayor or kebele chairman shall be nominated by election of the respective council, provided , however, whenever the state government deemed necessary shall appoint Renaissance Woreda Chairman, Renaissance city mayor, Renaissance kebele chairman.
- 3. Renaissance chairman or mayor shall be a deputy chairman or a deputy mayor who shall exercise powers and functions of the chairman of woreda or mayor of the city .
- 4. Woredas shall have a Deputy Chairman who shall be the head of one of main executive sector offices set up in the Woreda.

5. Inapplicable Laws

No law, regulation, directive or practice shall, in so far as it is inconsistent with this Proclamation, be applicable with respect to matters provided for by this Proclamation.

6. Power to Issue Regulations

The Regional Administrative Council may issue regulations necessary for the implementation of this Proclamation.

7. Effective Date.

This Proclamation shall enter into force up on its publication on Dhool Gazeta
