7. Engage in investment activities by selling bonds, borrowing with the guarantee of same, and involving in stock market ;
8. collect proper payment from services it delivers;
9. Generate the finance, man power and material utilization policy of the Enterprise using a strategy that is economical and based on market laws;

11. Meetings of the Board

1. The Board shall hold regular meetings once every two months; however, The Board may call extraordinary meetings at any time, as may be necessary;
2. The meeting shall constitute a quorum in the presence of more than half of the members.
3. The decisions of the Board shall be passed by the majority vote of the members present in the meeting. In the case of tie, the idea supported by the chair person shall be the decision of the Board.
4. Without prejudice to the provisions of this Article, the Board may adopt its own rules of procedures and manual.

12. Powers and duties of The General Manager

The General Manager of the Enterprise shall have the following powers and duties:

1. Shall direct, administer and supervise the activities of the Enterprise.
2. Shall organize the office of the Enterprise, formulate the organizational setup, salary scale and allowances of the Enterprise, submits to the Board and implement upon approval.
3. Opens and operates bank accounts in the name of the enterprise.
4. Prepare and present to the board the short, medium and long term work program of the enterprise and implement upon

approval;

18:- Power to Issue Regulation and Directives

2. The Council may issue directives necessary for the implementation of this Proclamation and the regulations issued pursuant to sub Article 1 of this Proclamation.
