BAYAANKA AAS AASIDA SANDUUQA KAYDKA GURMADKA DEG DEGA AH IYO KASOO KABASHADA MASIIBOYINKA

Maadaama Masiibooyinku si joogta ah uga dhacaan deegaanka Soomaalida, iyadoo ay sabab u tahay isbadalka cimilada islamarkaana waxyeelo ba'an u gaystaan nolosha iyo habnololeedka bulshada unugul masiibooyinka.

Maadaama masiibooyinku yihiin kuwo ka tan badan bulshadeena, dumiya hantida islamarkaasna dhaawac u gaysta dadweynaha wakhtiga dhaw iyo kan fog.

PROCLAMATION NO. 187/2012
A PROCLAMATION TO PROCLAIM AN EMERGENCY AND RECOVERY CONTINGENCY FUND IN SOMALI REGION

WHEREAS, Disasters consecutively in Somali Region resulting in damage on lives and livelihoods in disaster prone communities.

WHEREAS, disasters are tragedies that overwhelm our communities, destroy properties, and harm the population both the short and long terms.

WHEREAS, It is found necessary to establish a disaster emergency and recovery contingency fund to ensure a timely response when disaster strikes to avoid or reduce the possible impact of the disaster, for recovering the livelihood of disaster affected people and enable them to quickly recover from losses and damages resulted from disasters.

NOW, THEREFORE, The Council of the Somali Regional State in accordance with article 49(3, A) of the Revised Constitution, it is hereby proclaimed as follows:

GENERAL

1. Short Title

This proclamation may be cited as the Proclamation to establish Emergency and Contingency Fund in Somali Proclamation No. 187/2012.

2. Definitions

In this proclamation:-

- 1. "Region" means Somali Federal State.
2. "Bureau" means the disaster management Bureau
3. "Fund" is a source of resources obtained either in money and in kind.
4. "Contingency fund for Disaster" Means a resource that has been collected in terms of money and in kind which was collected from different sources to primarily support emergency response to enable people recover from losses and damages caused by any type of disaster, natural or man-made.
5. "Disaster" means a sudden disruption of the functioning of a community or a society involving widespread human, material, economic or environmental losses and impacts, which exceed the capability of the affected community or society to cope using its resources.
6. «Displacement Site» means a place where disaster affected people who lost their homes and livelihoods and non-food items including essential materials are provided.
7. "Relief" means activity undertaken in the immediate aftermath of a disaster to save lives, restore livelihoods, and address immediate humanitarian needs, including the provisional restoration of essential services such as Food and Water.
8. "Regular Support" means support provided by government to vulnerable people of recurrent droughts who are identified as eligible beneficiaries.

11. The Power and Duties of the Fund Administration Board

The Fund Administration Board shall have the following responsibilities:

1. Regularly evaluate data on disaster risk management, livestock, crops, and the security situation of the region.
2. Based on the result of the analysis presented by disaster management, the Board shall approve the emergency preparedness response plan for disaster-stricken communities.
3. By evaluating the findings of the assessment conducted, the Board shall declare the occurrence of a disaster in a specific area.
4. Approve the support for possible disaster that occurs within the region and present it to the Bureau.
5. Referencing the decision in the direction that has been set, the Bureau will mobilize the resources.
6. The office shall develop documents in relation to disaster management and developed strategic documents for approval from the board and will implement it.
7. Approve performance reports presented to it by the bureau.
8. Ensure whether the resources are utilized based on allocated budget.

12. Power and Duties of the Chairperson

The Chairperson shall:-

1. Call and lead the board meeting.
2. Assure on the implementation of the decisions of the board.
3. Represent the board in other forums or platform that concerns the fund.

13. Power and Duties of the Secretary

The Secretary of the board shall

1. Prepare the meeting agenda present to the chairperson
2. Take minutes of the board and share with board members
3. Responsible for keeping documents properly.
4. Execute other tasks assigned by the Board.

14 Meeting Procedures of the Board

1. The board shall have meeting on quarterly basis. it can also hold an urgent meeting whenever necessary.
2. A meeting shall be conducted by more than half of the board members available.
3. Decision shall be passed by majority vote; in case of a tie, the chairperson shall have a casting vote.
4. Without prejudice to other provisions of this Article, the Board may make up its own rules of procedure.

15. Unutilized Finance and Properties

The finance and properties of the board before the establishment of the disaster contingency fund and not yet transferred now on, it will be transferred to the disaster Contingency fund.
