መሬት ነፃ ንብረት ሊኖረው የሚችለው የህግ የለውጥ ዘመንና የልማት ስራ ወጪ መመለሻ የጊዜ ውስን እንዲሁም የልማት ስራውን ልዩ ባህሪ እና በመሪ ፕላን የሚወለን የቦታ አጠቃቀምን መሰረት በማድረግ በነፃ ገበያ መርሆዎች መሰረት የከተማ ቦታን በተገቢው ዋጋ በሊዝ ለማስተላለፍ አጠቃላይ ኢኮኖሚያዊና ማህበራዊ ልማትን ለማሳካትና የከተማዎችን ልማት በቀጣይነት የሚጎለብቡት አቅም እንዲፈጠር ለማድረግ እንደሚረዳ ስለታመነበት፡፡

ከእነዚህ ሁኔታዎች በመነሳትም ሊዝ ብቸኛ የከተማ ቦታ ይዞታ ስራት እንዲሁም ምቹ ሁኔታ መፍጠርና በመሪ ፕላን መሰረት ማልማት ስራ ታቅዶ ቦታ በሊዝ የሚፈቀድበት ሆኖ የሚያዝበት ሂደት የተቀላጠፈና ከመሰናከሎች የፀዳ እንዲሆን ማድረግ አስፈላጊ ሆኖ በመገኘቱ፡፡

**Content**

**Regulation no 91/2003**  
**The Somali regional state Urban Lands**  
**Leaseholding Regulation**

Whereas, the Constitutions of the Federal Democratic Republic of Ethiopia and of the region provides that urban land is a property of the State and the people and that it is necessary for executing the provisions of proclamation no 272/2002 on urban land lease tenure;

Whereas, it is believed that transferring urban land by lease for a fair price, consistent with the principles of free market, will help achieve overall economic and social development and to help build capacity enabling progressive urban development based on the life span that a landed property may have and the period it requires to recover Investment costs, the special nature of the investment and the land use specified in conformity with Master Plan;

Whereas, It has been found necessary, arising from those circumstances, to develop optimum conditions in which lease will become exclusive urban land-holding system and to remove obstacles of and to expediate the process of permitting and holding urban land by lease based upon investment plan made in conformity with master plan .

**ጠቅላላ**

**1. አጭር ርዕስ**

ይህ 'ደንብ የሶማሌ ክልላዊ መንግስት የከተማ ቦታ በሊዝ ስለመያዝ ለማድንገገ የወጣ ደንብ ቁጥር 91/2003 ተብሎ ሊጠቀስ ይችላል” ።

**2. ትርጓሜ**

የቃሉ አገባብ ሌላ ትርጉም የሚያሰጠው ክልሆን በስተቀር በዚህ ደንብ ውስጥ:-

1. “**አዋጅ**” ማለት የተሸሻለው የከተማ ቦታ በሊዝ እንደገና ለመደንገግ የወጣው የፌዴራል መንግስት አዋጅ ቁጥር 272/2002 ነው።
2. “**የከተማ ቦታ**” ማለት በከተማ ክልል ውስጥ የሚገኙ ማንኛውም የተገነባ ወይም ያልተገነባ መሬት ነው ።
3. “**ሊዝ**” ማለት የከተማ ቦታ የመጠቀም መብት በውል የሚተላለፍ ቦታ ወይም ይዘታ ስሪት ነው።
4. “**ከተማ**” ማለት በሶማሌ ክልላዊ መንግስት የከተማዎች መቋቋም እና አደረጃጀት ለመደንገግ የወጣው የክልሉ አዋጅ ቁጥር 91/2003 አንቀጽ 2 ሥር የተሰጠው ትርጓሜ ይኖራል።

Now, Therefore, in accordance with Federal lease Proclamation 272/2002 and Article 49 (3)(A) of the revised Constitution of the Somali regional state, it is hereby proclaimed as follow:-

**Part one**

**General**

Article 1. **Short Title**

This regulation may be cited as the “Regulation To Determine Urban Lands Lease Holding of Somali Regional State, Regulation No. 90/2003”

Article 2. **Definitions**

Unless the context requires otherwise, in this regulation:

- 1 “**proclamation**” means the Re-enactment of Urban Lands Lease Holding Proclamation No.272/2002.”
2. “**Urban land**” means land located within the boundary of an urban center;
3. “**Lease**” means a definite agreement grants for permission of land holding.
4. “ **Town**” shall have the definition given under Article 2 of the Proclamation of The Somali Regional State Urban Centers Establi-shment , Organization and Definition of their Powers and Duties

5. "Gole" Waxaa loola jeedaa golaha dhagaysiga iyo go'aaminta racfaanada laga soo qaato go'aanada la xidhiidha haysashada dhulka.

6. "Heerarka/darajooyinka magaalooyinka" waxaa loola jeedaa heerka darejo ee magaalo kasta la siiyo iyada oo laga duulayo heerka koboceeda.

7. "Darajada Jaggo" waxaa loola jeedaa heerarka darajo ee la siinayo jagooyinka magaalada iyadoo lagu saleynayo adeeg ay bixin karto qiimaha uu ugu fadhiyo bulshada.

8. "Dan guud" waxaa loola jeedaa dhulka ay hay'ada awooda u leh ay hab waafaqsan qorshe hagaha guud ee magaalada ama mid horumarineed ugu cayinto dan guud oo ay bulshadu si toos ah iyo si dadbanba uga faa'iideysto islamarkaana joogtaynaya koboca horumarineed ee magaalada.

9. "Jagooyinka soo jireenka" waxaa loola jeedaa jagooyinkii sida sharciga ah loogu haystay dhulka magaalada ka hor intii aan la soo saarin bayaanka liiska iyo maamulka kirada ee dhulka magaalada ee bayaan tirsi 8/91 sidoo kalana lagu faah faahiyay qodobka 7<sup>aad</sup> ee xeerkan.

10. "Shaqo ganacsi" waxaa loola jeedaa dhaqdhaqaaq kasta oo shaqo ah oo loo qabto ujeedo faa'iido doon ah, kuwaas oo ay ka mid yihiin shaqooyinka warshadaha, ganacsiga, beeraha, xirfadaha ama hawlaha shaqo ee kale iyo dhaqdhaqaaqyada faa'iido doon ee uu xeerka ganacsiga Itoobiya u aqoonsaday shaqo ganacsi.

11. "Adeegyo bulsho" waxaa loola jeedaa adeegyada iyadoon wax faa'iido ah laga rabin ee ay shacabku sida tooska ah uga faa'iidevstaan.

5. "ጉባኤ" ማለት የከተማ ቦታ ጉዳዮችን በሚመለከት የሚቀርቡ አቤቱታዎችን ለማየት እና ውሳኔ ለመስጠት የተቋቋመ አካል ነው።

6. "የከተማ እና ደረጃ" ማለት የከተማ የዕድገት ደረጃ መሰረት በማድረግ በአያንዳንዱ ከተማ የሚሰጠው የደረጃ ሥርዓት ነው።

7. "የቦታ ደረጃ" ማለት ቦታው ሊታበረከተው የሚችለው የአገልግሎት ሁኔታ እና በሕብረተሰቡ ዘንድ ባለው ዋጋ መሰረት በማድረግ የከተማ ቦታዎች ደረጃ ነው።

8. "የሕዝብ ትቅም" በቀጥታ ወይም በተዘዋዋሪ መንገድ ህዝቦች በመሬት ላይ ያላቸውን ተጠቃሚነት በማረጋገጥ የከተማ ልማት በቀጣይነት ለማጎልበት አግባብ ያለው አካል በመሪ ፕላን ወይም በልማት ዕቅድ የህዝብ ጥቅም ብሎ የሚወሰነው ነው።

9. "ነባር ይዘታዎች" ማለት የሊዝ አዋጅ እና የመሬት አስተዳደር አዋጅ ቁጥር 8/1991 ከማውጣቱ በፊት በሕጋዊ መንገድ የተያዙ ነባር የከተማ ቦታ ይዘታ እንዲሁም በዚህ ደንብ አንቀፅ 7 ሥር በተደነገገ መሠረት ነው።

10. "የንግድ እንቅስቃሴ" ማለት ዓላማው ትርፍ ለማግኘት የሚደረገው ማንኛም የስራ እንቅስቃሴ ሆኖ ከነዚህ ውስጥ የአንዱስትሪ ስራዎች ንግድ ግብርና ባለሙያ ወይም ሌሎች ስራዎች እና ሌሎች የኢትዮጵያ የንግድ ሕግ አንቅስቃሴዎች ናቸው ተብሎ የተደነገገ ነው።

11. "ማህበራዊ አገልግሎት" ማለት ዓላማው ትርፍ ለማግኘት ሳይሆን ሕብረተሰቡ በቀጥታ መንግድ ተጠቃሚ የሚሆንበት እንቅስቃሴ ነው።

5. "Commission" means a body established to examine and rendered a decision on appeals lodged againsts land holding by lease.

6. "Grade of Urban Centers" means a status incorporated to an urban center based on its level of development.

7. "Grades of Land" means the vares catagors to the type of urban land on based of service may provde and it's publil valve

8. "Public Interest" means that which an appropriate body determines as a public interest in conformity with Master Plan or development plan in order to continuously ensure the direct or indirect usability of land by peoples, and to progressively enhance urban development;

9. "Long Standng Tenure" means an urban land legally retained before the enactment of the proclamation of lease and admnistration of rental, proclamation no 8/91 and enumerated under Article 7 of this regulation.

10. "commercial activities" meina any kind of activities undretakng for purpose of the profit makng those includes industrial works, commercial work, agrcultural activity proffessional sercices or other activity and another ccommercial activities recognazed under commercial code of Ethopa

11. "social services" Means a kind of activities under taking for not purpose of profit making and directly benefit by the public at large

- 12. "Xafiis" waxaa loola jeedaa xafiiska hawlaha guud iyo horumarinta magaalooyinka ee Dawlada Deegaanka Soomaalida.
- 13. "Dhisme" waxaa loola jeedaa shaqada dhismaha guri ama dabaq ee laga dhiso jaggada lagu helay hab waafaqsan sharciga.
- 14. "Guddiga Maamulka Liiska" waxaa loola jeedaa guddiga uu magacaabo golaha hawl fulinta ee deegaanku oo u xilsaaran meel marinta xilka iyo waajibaadyada ku xusan qodobka 4aad ee xeerkan.
- 15. "Deegaan" waxaa loola jeedaa Deegaanka Soomaalida ee lagu qeexay qodobka 47<sup>aad</sup> farqadiisa 1<sup>aad</sup> tirsiga 5<sup>aad</sup> ee Dastuurka JDFItoobiya.
- 16. "Qof" waxaa loola jeeda qofka caadiga ama ciida uu sharcigu siiyay jiritaan qofnimo.

**Qaybta labaad**

**Qodobka 3<sup>aad</sup>:-Xadka Fulineed**

- 1. Xeer-nidaameedkan wuxuu dhaqan gal ku yahay dhamaan boosaska dhulka magaalo ee hada ka hor lagu haystay nidaam liis, go'aan maamul ama siyaabo kale ama dhulka la bixiyo wixii hada ka dambeeya.
- 2. Iyadoo arrinta lagu xusay farqada (1) ee qodobkan ay sideedada tahay, ayay golaha hawl fulinta deegaanku go'aamin xiliga iyo qaabka uu xeer-nidaameedkan loogu dhaqan galinayo dhulka magaalooyinka.

**Qodobka 4<sup>aad</sup>:- Habka bixinta jagoovinka magaalo**

- 1. Jagooviyinka magaalo waxaa liis ahaan lagu bixin karaa marka ay jaggadu tahay mid waafaqsan bilaanka guud ee dhulka magaalada.
- 2. Jaggada magaalo marka lagu bixinayo nidaamka liiska waxaa qiimaha lagu cayimi karaa qaab gor-gortan, tartan ama qaab ka madax banaan nidaamka liiska. Faah faahinteedana sharciga ayaa xeerin doona.

- 12. "ቢ.ር."ማለት የሶማሌ ክልላዊ መንግስት የስራና ከተማ ልማት ቢ.ር ነው።
- 13. "ግንባታ" ማለት በሕገ መሰረት የተገኘው የከተማ ቦታ የተገነባው የመኖሪያ ቤት ወይም ፎቅ ነው።
- 14. "የሊዝ አስተዳደር ቦርድ" ማለት በክልሉ ማስተዳደር ም/ቤት የሚሰየም እና በደንብ አንቀጽ 4 ሥር የተደነገጉ ስልጣንና ተግባር የሚያከናውን ነው።
- 15. "ክልል" ማለት በኢትዮጵያ ፌዴራላዊ ሕገ-መንግስት አንቀጽ 47(1)(5) የተጠቀሰው የሶማሌ ክልል ነው።
- 16. "ሰው" ማለት ማንኛውም ማንኛውም የተፈጥሮ ሰው ወይም በህግ የሰውነት መብት ተሰጠው አብል ነው።

**ምዕራፍ ሁለት**

**3. የተፈጻሚነት ወሰን**

- 1. ይህ ደንብ ቀደም ሲል በሊዝ ወይም በምረት ወይም በሌላ ሁኔታ በተያዘም ሆነ ከዚህ በኋላ በሚፈቀድ የከተማ ቦታ ላይ ተፈጻሚ ይሆናል ።
- 2. በዚህ አንቀጽ ንዑስ አንቀጽ 1 የተመለከተው ቢኖርም ማንኛውም የከተማ ቦታ ይዞታ ላይ ደንቡ ተፈጻሚ የሚሆነው የክልሉ ካቢኔ በሚወሰነው ጊዜና ሁኔታ ይሆናል ።

**4. የከተማ ቦታ በሊዝ ስለመፍቀድ**

- 1. የከተማ ቦታ በሊዝ እንዲያዝ የሚፈቅደው የከተማው ፕላን የማይቃረን ሲሆን የፕላኑን የቦታ አጠቃቀም ድንጋጌ ወይም ከተማው ፕላን የሌለው ሲሆን እንደየአግባቡ በክልሉ መስተዳደር ም/ቤት በሚወጣ ሕግ ይወሰናል ።
- 2. የከተማ ቦታ በሊዝ እንዲያዝ የሚፈቅደው የከተማ ቦታ የመነሻ ዋጋ በጨረታ ወይም በድርድር ከጨረታ ውጪ የሚወሰን ይሆናል ።

- 12. "Bureau" means Public Works and Urban Development Bureau of Somali Regional State.
- 13. "Construction" means the construction works of a housing erected on land permitted in accordance with the law;
- 14. "Lease Board" means the board to be designated by the executive council of the region to exercise the powers and duties specified for under article 4 hereof.
- 15. "Region" means the Somali Regional state indicated under Article 47 (1) 5 of the Constitution of the Federal Democratic Republic of Ethiopia,
- 16. "Person" means any natural person or any body Designated as a person by law.

**Part Two**

**Article 3. Scope of Application**

- 1. This regulation shall be applicable to an urban land held by the peasant system, or by leasehold system or other means prior thereto, as well as to an urban land permitted hereafter.
- 2. Notwithstanding the provision of Sub-Article (1) of This Article, the executive council of the Region shall set time and conditions under which this regulation shall be applicable to any town in the region.

**Article 4. Lease Hold Permit**

- 1. An urban land shall be permitted to be hold by lease where such land conforms with plan guideline and where it does not exist in conformity with the law which the Regional Government makes in the case may be,
- 2. Where urban land is to be permitted by lease, may determined shall be on auction, negotiation or through other means the detail shall be specified by law .

3. Qiimaha liis ee darajo kasta oo jaggo wuxuu noqon mid si cad loo cayimo oo uu mar walba xafiisku isaga oo darsaya uu ka ansixin golaha hawl fulinta ee deegaanka.

**Qodobka 5<sup>aad</sup>:- Darajada(heerarka) magaalo**

1. Si loo aburo jawiga ku haboon dhaqan galinta nidaamka liis iyo koboca horumarka dhaqaale ee magaalooyinka deegaanka ee laga hirgalinayo nidaamka liis xafiisku daraasaad ku sameyn heerarka magaalo ee magaalooyinka deegaanka, darajooyinka kala duwan ee ay jagooyinka magaalooyinku iyo qiimaha liis ee ay yeelanayaan.

2. Arrimaha daraasada lagu sameeyay ee ku cad farqada 1<sup>aad</sup> qodobkan waxaa awaamiir ku xeerin golaha hawl fulinta deegaanka.

**Qaybta Saddexaad**

**Qodobka 6<sup>aad</sup>:- Jagooyinka magaalo ee horey loo haystay**

Iyada arrimaha lagu xusay Qodobka 3<sup>aad</sup> ee xeerkani uu sidiisa yahay, ayaa jagooyinka magaalo ee horey loo haystay ay ka koobnaan kuwa hoos ku xusan:-

- 1. Ka hor intii aan la soo saarin xeerkan :-
- B. Jagooyinka magaalada ee xujada sharciya lahaa islamarkaana aan lala wareegin.
- T. Jagooyinka lahaanshahooda mulkiyadeed loo haysto caddeymo sharci ah.
- J. Jagooyinka si sharci ah loola kala wareegay mulkiyadooda islamarkaana caddeynta lahaanshaha laga haysto hay'ada ay khuseysay.
- X. Jagooyinka uu maamulka xaafadu uu si sharci ah u siiyay ama u diwaan galiyay lahaanshahooda.
- Kh. Dhulka wixii ka horeeyay ansixinta xeerkan lahaanshahooda sharci loo go'aamiyay in uu leeyaha maamulka dawlada deegaanku iyo kuwa kale ee mustaqbalka la go'aamin doonaba waxaa lagu faah faahinayaa sharciga.

3. The lease price applicable for each grade of land shall be clearly set determined by the executive council of the region where the bureau implements a regular study and recommends to it.

**Article 5. Grading the Status of Urban Towns**

- 1. The bureau shall study the status of the towns of the region, the grades of the land sites as well as the price in order to facillitate the effectiveness of the lease system and to creat favourable conditions for all-rounded growth and development of the towns.
- 2. Matters studied persunant to sub - article 1, hereof, shall be determned by directives to be issued by the executive council of the region.

**Part Three**

**Article 6. Existing possession of urban land**

- 1. Notwithstanding the provisions of article 3 of this regulation, the following possession of urban land shall be considered as Existing possession of urban land before this regulation,
  - A). an urban lanad lawfully grant with title deed and not confiscated by the state.
  - b). urban land holdings which could submit ownership certificate
  - c). an urban land which their ownership have been legaly transfer to and the title deed has been transferred by appriprioate organ.
  - d). an urban land registered or granted by kebele administiration in accordance with the law.
  - e). an urban land which its ownership is granted to the regional government before the coming into effect of this regulation or may be determined for in the future. Law shall determine the particulars.

- 4. Marka ay noqoto in lagu maamufo nidaamka liiska jaggio horey loo haystay, qiimaha liisku wuxuu noqonayaa cel-celiska qiimaha tar-tanka ee uu yaal jaggiooyinka ku hareeraysan. Hase ahaate, hadii la waayo qiime sugan wakhtigaas wuxuu qiimaha jaggadu noqoni qiimaha loo cayimo wakhtigaas.

- 1. Baaxada dhuleed ee qaab qori tuur ah (bakhtiyansiibka ah) loogu siiyo iskaashato ama shaqsiyaad in ay ka dhistaan guryaha hooyga ah iyadoo ay tahay mid ku xidhan nooca heerka magaalo ayaa darajada koowaad ee magaalo la siin 150 kaare mitir magaalooyinka kalana waxay noqon illaa 300 kaare mitir. Faah faahinta arrintaana awaamiir ayaa lagu xeerin.

**7. ለግል መኖሪያ ቤት መስሪያ የሚፈቀድ የቦታ መጠን**

- 1. የከተማ ቦታ በአጣ ለማህበር ወይም ለግለሰብ የግል መኖሪያ ቤት መስሪያ የሚሰጠው የቦታ መጠን እንደየከተማው ደረጃ ዓይነት ሆኖ ለአንደኛ ደረጃ ከተማ እስከ 150 ካ.ሜ ሲሆን ለሌሎች ከተሞች ደግሞ እስከ 300 ካ.ሜ ይሆናል። ዝርዝሩ በመመሪያ ይወሰናል።

- 2. The rate of lease payment applicable to the matters provided under (A-E) of this Article shall be determined by directive to be issued by the executive council of the region.
- 3. Notwithstanding sub-article 1 and 2 of this Article, the long-standing urban land holdings may be administered by the lease system;  
 A). any change of demissions made on long- standing holdings; subject to advance payment for the extra lands.  
 b). any transfer of holding made to a third party in accordance with the law.
- 4. When long-standing land tenure comes under the lease administration system, the lease payment shall be the average of the negotiable price determined for the surrounding lands. However, where there is no a fixed price for a time being, the price of the land shall be the payment determined for the time being.

**Article 7. The size of land granted for the constructon dwelling houses**

- 1. The size of land granted through chance for the constructon dwelling houses permitted to individual or Association may vary according to the grade of the urban shall be permitted for first grade of urbans 150km<sup>2</sup> , For other urban lands it shall be upto 300km<sup>2</sup>. Details shall be determined by directives.
- 2. Applicants of plot of land greater than the size specified under sub-Art One hereof, may only b e permitted through on auction or through negotiation and subject to the cost of the value of the land.

Qiiimaha liis ee sannad kasta laga bixinayo jagooyinka lagu qeexay farqada laad ee qodobka 7<sup>aad</sup> ee xeerkan, wuxuu noqon cadadka u dhexeeya 0.18 illaa 0.50 kaare mitirkiiba. Qiyaasta qiime oo faah faahsan waxaa awaamiir ku xeerin guddiga maamulka arrimaha liiska.

**Qodobka 9<sup>aad</sup>:- Habka bixinta shahaada cadaynta ee haysiga liiska iyo fasaxa dhismaha**

1. Qof kasta oo liis ahaan lagu siiyay dhul ka mid ah dhulka magaalada marka uu keeno heshiis caddeynaaya in uu dhulkaas liis ahaan ku kireystay ayaa la siinayaa shahaadada caddeynta lahaanshaha liiska.

2. Marka isbadalka adeega lagu fasaxo qaab waafaqsan xeerkan qodobkiisa 14<sup>aad</sup> waxaa la bixinaya caddeyn muujinaysa qiiimaha isbadalay ee sannad kasta laga bixin doono liiska.

5. The lease board by virtue of decisions of the Regional executive council or woreda Administrative organs may by special gifts permit an urban land for lease payment down to nil for undertakings of private dwelling houses for their contributions to encourage.

6. An existing possession of a rural land on which a building is situate by the peasants covered by expansion of the master plan which doesnot contradict with the plan of the town in addition to 500km<sup>2</sup> to be conferred shall be entitled to payment of compensation commensurate to the value of the property and development made on land so far

**Article 8. Rate of Lease Payment on dwelling houses**

The Rate of lease payment subject to be paid every on type of land mentioned under sub- article 1 of article 7 of this regulation shall be a rate of between 0.18--- 0.50 /km<sup>2</sup>. Details of payment rate shall be determined by a directive to be issued by the lease board.

**Article 9. Lease-Hold Title deed**

1. Leasehold title deed shall be conferred on a person to whom an urban land is permitted, after dully produced a contract of lease permitted with the land.

2. Where the conversion of the type of service in respect of which leasehold of the urban land has been pennitted persunant to Article 14 of this regulaton there shall be issued a certificate defining the varied rate of payment annuly due.

2. የክልሉ መንግስት ሊያበረታታቸው የልማት ስራዎችና ለመሀበራዊ አገልግሎት የሚውል የከተማ ቦታ በድርድር ወይም ያለድርድር በነፃ ሊሰጥ ይችላል። ዝርዝር ከፈላጭ የሊዝ ቦርዱ በሚያወጣው መመሪያ ይወሰናል ።

3. The details to be contained in title deed and building construction permits shall be specified in directives to be issued by the Board. Particulars in the title deed shall be as follows;

- A). date of signing of the contract and the full name of the possessor;
- B). size of the land and area situated;
- C). the total amount of lease of the land;
- D). the period of lease;
- E). the ceilings for the additional period of payment for the lease;
- F). amount of advance payment;
- G). commencement date of construction and completion deadline;
- H). the time and conditions to be finalized the remaining payment;
- I). whom registered and the authority that issued the certificate;

**Article 10:- Period of Grace for Encouragement**

1. Any person to whom a permit for payment of urban land is permitted may be granted a period of grace for two or three years for consideration for the type of development and service. Details for this provision shall be determined based on the directives to be issued by the lease board.
2. The Regional government may permit urban land for development activity and so encourage which it purports to encourage with out on auction or negotiation for lease payment down to nil. Details for this provision shall be determined in the directive to be issued by the lease board.

**Article 11. Commencing and up Period of constructions**

1. A construction work is have begun where an exca activities and fastening of bars for the base is comp However, the constructio fencing and service rooms not constitute as commenc of a construction.
2. Any person granted an urban through lease should beg construction activties within months from when constru permit is issued.
3. Any person granted an urban through lease should beg construction activties within months from when construc permit is issued and shall fina within two years. However, w the time for strating and finaliz required for construction greater then the aformentio starting and finalizing time organ with whom contracted w may extend inline with complexity of the work the de determined by the law.

Any peron who permitted a land in accordance with article 10 sub-article 1, and failed to begin the construction of the land inline with the time limit under sub-article 2 of article 10, subject to the reduction of 3 % of the total amount of land lease deposit as penalty, the land shall be given to another person.
6. the lease-hold of urban land permitted persuanent to sub-article 3 of article 10 and sub-article 2 of article 16 where the lease-hold possessor has failed to use the land in accordance with Sub-Article (3) of this Article, the lease-hold of urban land shall be terminated and transferred to another person.
7. Where the construction isnot strated the time specified under Sub-Article 2 and 3 hereof, .Penalty under sub-article 4, 5 and 6 may not, however, be due where the bureau or the town administration asertains the land fells short of use because of force majuere set forth uncder Article 1793 of the Civil Code.
8. Any person who has strated the construction work of leasehold of urban land in accordnce with sub-article 1 of this article must finalize the work as per plan schdule submitted together with the time limit for commencement and the finalization of the work.
9. Where the leasehold of urban land failed to finilize the construction work in accordance with Sub-Article (8) of this Article, it shall constitute as a ground for termination of leasehold contract persuanant to sub-article 1(A) of article 15 of the proclamation.

9. Each City Government or municipal town shall utilize at least 90 per cent of the lease payment it collects, from sale by leasing urban lands for the purpose of expanding infrastructures. City or municipal administration shall submit a report showing the expenditure for this purpose of the revenue it collects from this service. As well as infrastructures, section of municipality shall fellowup implementation of it.

10. Every urban administration shall have its own bank account to deposit the revenues it collects from lease.

11. The base of the rate of lease payment shall be determined by a directive to be issued by executive council of the Region.

**Article 14 changing the use of the land**

1. Any person, to whom leasehold of urban land is permitted, must begin to use the land for the prescribed activity"or service only.

2. the land use may be converted as per a permit' granted in writing by the appropriate body after application to convert the type of development or service in respect of which lease-hold of the urban land has been permitted is received. However the upon the conversionof the 'land use, Period of lease, performance of payment and shall be varied and be that applicable to new changed services.

3. Changes of service shall be granted by public works and urban developmen Bureau or by cities Administrations.

- 2. Without prejudice the provisions of sub-Article 1 of this A the outstanding leasehold of urban land may not be exempted. However upon the approval of this regulation may be adjusted to the rate of the amount payable in accordance with the provisions of this regulation without varying the Period of Lease contract.

**Article 19. Transfer of Rent Holdings to Lease Holdings**

Any rent system of possession may be transferred to lease holding system in the following manner;

**Article 20. Clearing Urban Land**

1. The municipal office may clear and take over an urban land, which it decides it is necessary to commit for a public interest by issuing clearance order in writing to the concerned person within in period of three months. It shall also publicize the order through other alternative means.

2. It is only before the following bodies that any justifiable claim relating to a clearance order or a warning notice may be invoked: primarily only before the body, which has issued. The order, on appeal before Urban Land Clearance Appeals Commission, and, on appeal concerning compensation claims only, before the High Court having jurisdiction over the place where the property is situate or before the Municipal Appellate Court.

3. The appropriate body may clear urban land with a property thereon from illegal holders by serving written notice warning the person having illegally held it to move away and without any need giving him clearance order and compensation in accordance with the Proclamation. It may take over the land illegally held by clearing from the holder and, where it finds it necessary by using the police force.

4. The body, which handed the urban land over to the leasehold possessor may take over the land, together with the property thereon without any payment, where the latter has failed to remove the property on the ground within the period set forth in Sub-Article (6) of Article 18. It may order The Police where it finds necessary for the execution thereof.

**Article 21. Lease board**

1. The board shall have seven upto nine members coming from different relevant bodies.
2. The term of office of the lease board shall be for a period of three years, however, a member may be re-elected in the second term for the membership.
3. The chairperson and other Members of the lease board shall be designanated and removed by the executive council of the region and the executive body of the worda, as it may be appropriate.
4. The Lease board shall have its own structure that executes proffisional duties.
5. Amounts of allows attributable to the members and secretiriates of the lease board shall be determined the executive council of the region.
6. The lease board shall have its own office. Directives shall determine Powers and duties of each office.

**Article 22. Meeting procedures of the board**

1. The lease board shall discharge it is duiies by conducting its meeting of least once in an every months.
2. The presence of majority of members at any board meeting shall constitute a quorum.
3. The decision of the borad shall be passed by simple majority vote of the members present at the meeting. Provided, however, the chairperson shall have a casting vote in case tie.
4. Where there is, a destenting opinion shall be registered in the minutes of meeting.

7. Shall examine on appeals beyond the jurisdiction of subordinate lease board, urban development office of the city as well as zonal branches submitted to it and shall provide a final decision.
8. Based on the records of the development activities of the region shall device directives determining the type of incentives should be granted to the development activities and social services moreover, submittees for approval to the investment board of the regional government.
9. Determine the appropriate the lease period applicable to economic and social development undertakings intended to be invested on urban lands not designated for use within a short period.
10. By determining the minimum price rate to be charged against the possession of the lease holding of land through negotiations and shall causes that the public works and urban development bureau should communicate with the beneficiary the result of its decision towards the price .
11. Submittes to the council of the regional state for approval on policy issues arising in connection with this regulation;

12. **Part six**

**Article 24. Institution of Pleadings and Decision-making**

1. A person upon whom compensation order is issued as indicated in Sub-Article (1) of Article 21 or any other person upon whom an order of infringement of his right or of any person upon whom a notice is served, may take appropriate body his claim in respect of compensation or other grievance of a judicial nature, with substantiated evidence and reasons. 'The body receiving the claim brought before it as, 'set forth in Sub-Article (1) of this Article sub 2 of article 21 of the regulation shall ascertain the property, which is subject to compensation, is legally bound.
2. The body receiving the claim shall record and keep the estimate of the amount of compensation on the grounds of assessment process followed in its respect of the property under Sub-Article (2) of Article.

**Article 25. Appeals**

1. An applicant, who disagrees with a decision rendered, according to Sub-Article (2) of Article 25, may appeal before the Commission within 30 days as from the date of the decision. It shall, however, be deemed as if he has accepted the decision if he has not appealed within this time.
2. The Commission shall examine the appeals brought before it and render decision on them in accordance with sub-article 1. Hereof, the Commission shall notify its decision in writing to the parties concerned. The Commission shall deliver upon Disputes of Law and Fact shall be final and binding. Disputes for Compensation shall be final and binding.

**Article 26:- The Commission**

1. In accordance with Article 19 of the proclamation, there shall be established an Appealate Commission in centers where lease police is applied and, which shall have jurisdiction to examine appeals decisions on Compensation Orders brought before it as stated forth in sub-Article (1) of Article 23 of this regulation.
2. The accountability and the number of members of The Commission shall be determined by the Council of the regional state.
3. Without prejudicing the provisions stated under article 19 (8) of the proclamation, executive Council of the regional state shall determine the working procedures and the term of office of the Commission.

**Part Seven**

**Miscellaneous Provisions**

**Article 27. Inapplicable Laws**

No laws, regulations, directives or practices that are inconsistent with this regulation shall have any effect.

**Article 28 Duty to Co-operate**

Any person shall be duty bound to co-operate where he is asked to do so in any operation undertaken to give effect to this regulation.

**Article 29. Penalty**

Any person who Obstructs or delays the execution of matters as set out in Article 20 of the proclamation shall be liable to entail penalty in accordance with the relevant Penal Code.

**Article 30. Power to Issue Directives**

1. The regional executive may issue directives necessary for the implementation of this regulation.
2. Notwithstanding with the provision of sub- article 1 of this article, other executive may issue detailed directives on matters specifically assigned to them.

**Article 31. Transitory Provisions**

1. Matters, which have been under consideration before any court and which are liable to be transferred to the lands Permitted by lease and other administrative orders in force at the time this Regulation becomes effective shall be Transferred to the hands of the Court adjudicated by the Court according to this Regulation of the time this Regulation becomes effective.
