3. **ማሻሻያ**

የሶማሌ ክልላዊ መንግሥት የተሻሻለው የአስፈፃሚ አካላትን ሥልጣን እና ተግባር መወሰኛ አዋጅ ማሻሻያ ቁጥር 209/2014 እንደሚከተለው ተሻሽሏል።

1. በአዋጁ አንቀጽ 4 ስር ተራ ቁጥር (23) ተሰርዞ በሚከተለው አዲስ ተራ ቁጥር (23) ተተክቷል።

19) በነዳጅ ፍለጋ፣ ምርት እና አጠቃቀም ላይ ከተሰማሩ የፌዴራል አካላት ጋር የቅርብ የሥራ ግንኙነትና ትብብር ያደርጋል።

20) የነዳጅ ሀብት አጠቃቀም እና አመራረት በማህበራዊ ላይ የሚያስከትለውን ተጽዕኖ ለመገምገም የሚያስችሉ ጥናቶችን በማካሄድ ተገቢው ምክራ-ሀሳቦችን ያቀርባል።

2. **Definition**

“**proclamation**” means the Proclamation to Provide for The Reorganization, Powers and Duties of the Executive Organs (Amendment) Proclamation No. 185/2019 And Proclamation No. 209/2022

3. **Amendment**

The Reorganization, Powers and Duties of the Executive Organs of the Somali Regional State Proclamation no 209/2022 (as amended) is hereby amended as follows:

1. the Serial number (23) under Article 4 of the Proclamation is deleted and replaced by the following new Serial number (23):

23'' **Mining, Energy and petroleum Bureau''**

The Reorganization, Powers and Duties of the Executive Organs of the Somali Regional State Proclamation no 185/2019 is hereby amended as follows:

2. The following new sub article (19, 20, 21, 22, 23 and 24) is added after sub article (18) of Article 35 of the Proclamation (as amended):

19) work with and cooperate closely with the Federal organs involved in the exploration, production and utilization of petroleum resources;

20) Conduct studies to asseess on the social impact of the exploitation and production of petroleum resources and provides recommendations on it.

- 23) wuxuu kaalmaha shidaalka siiyaa shahaadada muujinaysa in goobta kaalinta shidaalka laga dhisayaa ku hoboontahay shaqada shidaalka iyo amaanka;
- 24) wuxuu dabagalaa islamarkaana hubiyaa in kaalmaha shidaalku u hogaansamaan shuruucda u degsan, waxaanu ku soo roгаа ganaax sharciga waafaqsan marka lagu helo khaladaad cad cad.

21) አግባብነት ከላቸው ፖሊሲዎችና የህግ ማዕቀፎችን በመከተል የነዳጅ ሥራዎች በሚከናወኑበት አካባቢ የአካባቢ ማህበረሰቡ የነዳጅ ፍለጋ ወይም ምርት ከሚውል መሬት የሚከፈለው የሮያሊቲ ታክስ ተጠቃሚነታቸውን ያረጋግጣል፤

24) የነዳጅ ማደያዎች አግባብነት ያላቸውን ህጎች መከበራቸውን ይከታተላል፤ ያረጋግጣል፤ እንዲሁም ክፍተቶች በሚታዩበት ጊዜ አስተዳደራዊ ቅጣትን ይጥላል።

4. **አዋጁ የሚጸናበት ጊዜ**

ይህ አዋጅ በክልሉ ምክር ቤት ከፀደቀበት ቀን ጀምሮ የጸና ይሆናል።

- 21) following the appropriate policies and laws, administer and ensures that the community has well benefit from the royalty tax paid from the land used for petroleum exploration or production;
- 22) makes suggestions to the relevant organs the need for conducting a scientific study when deemed or discovered any damages sustained due to petroleum exploration processes and to be disclosed;
- 23) Issue competency certificate to new constructed petroleum products retail stations that meet the requirement and safety standard,
- 24) Follows-up and ensures that the petroleum products retail stations comply with the appropriate laws, and impose an administrative penalty wherever gaps are observed.

4. **Effective Date**

This Proclamation shall enter into force upon the date of approval by the State Council.
